MAY IT PLEASE THE TRIAL CHAMBER

- 1. On 13 June 2014, the Defence for Mr KHIEU Samphân ("the Defence") filed its lists of proposed documents for Case 002/02.¹
- 2. On 30 June 2015, the Trial Chamber ("the Chamber") issued a decision on the admissibility of the documents proposed by the parties, wherein it stated:

To assist the Chamber in assessing whether three lengthy German-language documents submitted by the NUON Chea Defence and the KHIEU Samphan Defence are relevant to Case 002/02, and to avoid overburdening the Interpretation and Translation Unit with unnecessary translation requests, the Defence are requested to file an indication of which portions of these documents it seeks to put before the Chamber. This should include where possible an expanded description of their nature and contents as well as citations to the relevant points of the Closing Order. Such indication should be filed within 14 days of the filing of this decision.³

- 3. Of the three documents mentioned by the Chamber, two were proposed by the Defence: D359/1/1.1.28 and D359/1/1.1.53.⁴
- 4. The Defence hereby informs the Chamber that it provided all of the requested information concerning the two documents when it filed its lists a year ago.⁵ Accordingly, it invites the Chamber to refer thereto.
- 5. The Defence would, however, point out that the relevant page of document D359/1/1.1.28 was incorrectly stated as ERN 00537031, whereas it should be ERN 00537032.
