### Summary of Proceedings

### Opening of hearing and report on attendance of the Parties

The President opened the proceedings and the Greffier informed the Trial Chamber that all Parties were present. The Accused NUON Chea was present in the holding cell.

### NUON Chea Defence request to follow the proceedings from the holding cell

The Trial Chamber granted the request of the NUON Chea Defence for NUON Chea to waive his right to be present in the courtroom and to follow the proceedings from the holding cell.

# NUON Chea Defence's submissions regarding the International Co-Prosecutor's request for additional witnesses (E366)

The NUON Chea Defence requested clarification from the International Co-Prosecutor and National Co-Prosecutor as to why the request for additional witnesses (E366) was signed only by the International Co-Prosecutor. The NUON Chea Defence also submitted

that it cannot properly read and process all the documents disclosed from Cases 003 and 004. It therefore asked to be given either additional "resources immediately" or an adjournment of the hearings on the treatment of the Cham. The KHIEU Samphan Defence also raised the issue of time and resources necessary to process such documents, and recalled its submissions on the Co-Prosecutors' disclosure obligations. The International Co-Prosecutors responded that investigations are on-going and that therefore they will continue to disclose documents. They however have no objection to the Defence teams to be given more time where reasonable requests are made.

The Trial Chamber ruled that following the questioning of the Civil Party HIM Man (2-TCCP-252) by the Civil Party Lead Co-Lawyers and the Co-Prosecutors, it would adjourn the hearings for the week of 21-25 September 2015. The hearings would resume on 28 September 2015 with the questioning by the Defence teams of Civil Party HIM Man (2-TCCP-252).

### Hearing of Civil Party HIM Man (2-TCCP-252)

The Trial Chamber, the Civil Party Lead Co-Lawyers and the Co-Prosecutors posed questions to the Civil Party HIM Man (2-TCCP-252).
