Summary of Proceedings

Opening of hearing and report on attendance of the Parties

The President opened the proceedings and the Greffier informed the Trial Chamber that all Parties were present, with the Accused NUON Chea present in the holding cell.

NUON Chea Defence request to follow the proceedings from the holding cell

The Trial Chamber granted the request of the NUON Chea Defence Team for NUON Chea to waive his right to be present in the courtroom and to follow the proceedings from the holding cell.

Hearing of Witness 2-TCW-894

The Civil Party Lead Co-Lawyers, The NUON Chea Defence, The Trial Chamber, and The Khieu Samphan Defence questioned the witness 2-TCW-894 in closed session.

Oral Submissions on the request by the NUON Chea Defence to remove witness 2-TCW-989, from the witness list for the proceedings in Case 002/02

On 15 January 2016, the NUON Chea Defence submitted a request to remove witness 2-TCW-989 from the list of approved witnesses by the Trial Chamber to testify in case 002/02 (E346/2/1). The Co-Prosecutors, Civil Parties and KHIEU Samphan Defence give oral submissions to this request. The Trial Chamber will issue a ruling in due course.

Hearing of Witness 2-TCW-938

The Trial Chamber and the Co-Prosecutors questioned the witness [REDACTED] 2-TCW-938 in closed session.

<u>Clarification on the newly disclosed documents E319/39.3.5 by the Co-Prosecutors to the</u> Defence Teams

The Trial Chamber sought clarification from the Co-Prosecutors on the use of the newly disclosed investigative report (E319/39.3.5) to the Defence teams on 8 January 2016. The Co-Prosecutors stated they were not planning on using the documents, therefore did not file an 87.4 request, but that some of the information contained in them may be exculpatory. The KHIEU Samphan Defence team filed an 87.4 request to use one of the documents, to which the Co-Prosecutors had no objection. The Co-Prosecutor and Civil Party lead Co-Lawyers had no objection to admitting the Investigative report. The NUON Chea Defence had no objection, but requested access to all 13 Written Records of Interviews mentioned in the report, and the KHIEU Samphan Defence objected to the use of the report since they were unable to review the relevant WRIs within which the investigators used questionable methods. The Trial Chamber allowed the use of the investigative report in the proceedings but ordered the Deputy Co-Prosecutor to ask very open questions.
