1. Pursuant to Rules 87(3) and 87(4), the Co-Prosecutors request that the Trial Chamber admit the S-21 photographs submitted in **Annex 1** hereto as part of existing Case File 002 admitted document **E3/9214**.
2. In their Trial Document List filed on 13 June 2014, the Co-Prosecutors proposed for admission a new collection of S-21 photographs obtained by DC-Cam following the Case 002 judicial investigation and the start of the Case 002 trial, as No. 66 in Annex C2.<sup>1</sup> In that filing, the Co-Prosecutors advised that DC-Cam was only able to provide a list or index of the new photographs at that time, as the photographs were being used for an exhibition and were not available for copying.<sup>2</sup> The index of the S-21 photographs was submitted as ERN 00993310-66, and was subsequently put on the Case File by the Trial Chamber as Document **E305/13.23.66** and admitted as **E3/9214**. Copies of the photographs listed in **E3/9214** were first made available by DC-Cam this week, and are attached as **Annex 1** hereto (ERN P 01223690-01223847).
3. The submitted photographs are relevant to the S-21 security office segment of Case 002/02 and meet the criteria for admission under Rule 87(3). They are part of a document that was included by the Co-Prosecutors in their June 2014 Trial Document List, which has already been approved for admission by the Trial Chamber. To the extent Rule 87(4) is applicable, the photographs themselves were not available prior to the opening of trial, and copies were only obtained from DC-Cam in the past week. The photographs also relate “closely to material already on the Case File” that has been admitted by the Chamber.<sup>3</sup>


