Dear Ken, dear parties,

The Co-Lawyers for Nuon Chea (the "Defence") have asked me to write so as to circulate courtesy copies of two filings for your information.

We submitted the first filing to the electronic system in the morning on Friday, 8 April, but for reasons unknown to us, it is yet to be notified to you all. This filing is a Rule 87(4) request to admit three letters, one video and one audio file in relation to the late King Father Norodom Sihanouk. In addition to a courtesy copy of the request, we also attach a PDF of the letters. The video file and its transcript are on the Shared Materials Drive, at V01219576 and ERN 01221752 respectively. The audio file and its transcript are also on the Shared Materials Drive, at V01219575 and ERN 01221751.

The second filing is a Rule 92 motion to use certain S-21 statements for which there is no real risk that they were obtained through torture. We have already submitted this filing to translation. Due to the upcoming public holidays, this translation will not be complete until early next week, at which point we will file the motion officially.
