The Co-Lawyers for Mr. Nuon Chea wish to make the following response to the Co-Prosecutors' request for an extension of time to respond to Mr. Nuon Chea's request to admit several documents in relation to the late King Father.

Mr. Khieu Samphan's support to Mr. Nuon Chea's request does not add thereto any substantial or new arguments.

Moreover, the Co-Lawyers for Mr. Nuon Chea sent a courtesy copy of the Rule 87 (4) request together with all attachments to the Chamber and the parties on 11 April 2016, one day before the request was officially notified, which in effect gives the parties more time than they are entitled to consider their responses.

Based on the above, the Co-Lawyers for Mr. Nuon Chea request that the Chamber dismiss the Co-Prosecutors' request for an extension of time to respond to Mr. Nuon Chea's request.
