Subject: Re: Request to Respond to NC and KS Rule 87-4 Requests Combined by 26 April 2016

Dear Parties

The Trial Chamber has considered the Co-Prosecutors' email request to file, by Tuesday 26 April 2016, a combined response to: (1) NUON Chea's motion of 12 April 2016 (E396); and KHIEU Samphan's subsequent submissions (E396/1), both of which relate to documents and speeches said to be authored by King Sihanouk.

The Trial Chamber has also considered the points made by the NUON Chea team in reply to the Co-Prosecutors' email request.

On an exceptional basis, the Trial Chamber grants the Co-Prosecutors' request to file a combined response by Tuesday 26 April 2016. However, the Trial Chamber notes that all Parties are expected to organize their workloads and adhere to deadlines. The Trial Chamber reminds all Parties that they must respect the relevant deadlines as provided for in the Internal Rules, or request an extension of time at the earliest opportunity. On this particular occasion, however, the Trial Chamber notes with concern that Parties have faced a number of Rule 87(4) motions made at a very late stage indeed, shortly before the relevant persons were due to give evidence before the Trial Chamber.
