Dear Xiaoyang, dear Parties,

Further to the NUON Chea Defence's email request for leave to file replies to the Civil Party Lead Co-Lawyers' and the Co-Prosecutors' responses (E399/1 and E399/2, respectively), the Chamber has asked me to inform you that it:

- a) Grants the NUON Chea Defence leave to file a reply;
- b) Noting that 13 May is an ECCC holiday, Rejects the NUON Chea Defence's request to be allowed to file replies to E399/1 and E399/2 on 13 and 16 May 2016, respectively, and Orders that a single reply be filed on Thursday 12 May 2016, thus granting the NUON Chea Defence an extension to the five-day time period for the filing of replies as provided for in Article 8.4 of the Practice Directions on Filing Documents before the ECCC (Revision 8); and
- c) Grants leave to file the reply in English only, with the Khmer translation to follow as soon as possible.

The Trial Chamber recalls that, in accordance with its oral ruling of 3 May 2016, the NUON Chea Defence team has been granted two weeks of preparation time for the examination of witnesses 2-TCW-816 and 2-TCW-916, with the Chamber only resuming hearings on 23 May 2016.
