The Co-Lawyers for Mr. Nuon Chea (the "Defence") thank the Chamber for granting the Defence more time and leave to file in one language.

In light of the decision by the Chamber for the Defence to file one combined reply to both responses, the Defence seeks the Chamber's leave to extend the page limit to 30 pages in English.

The Defence submits that this extension is justified by the need to combine replies to two separate responses - which as argued by the Defence in its request for extension of time contain arguments that do not overlap each other - as well as the complexity of the issues involved.
