Summary of Proceedings

Opening of hearing and report on attendance of the Parties

The President opened the proceedings and the Greffier informed the Trial Chamber that all Parties were present, with the Accused NUON Chea present in the holding cell.

NUON Chea request to follow proceedings from the holding cell

The Trial Chamber granted NUON Chea's request to waive his right to be present in the courtroom and to follow the remainder of proceedings from the holding cell.

Hearing of witness HIM Huy (2-TCW-906)

The Co-Prosecutors, Trial Chamber, Lead Co-Lawyers and NUON Chea Defence questioned witness HIM Huy (2-TCW-906).

Objection by NUON Chea Defence to witness HIM Huy (2-TCW- 906) declining to respond to a question

Following advice from his Duty Counsel, Witness HIM Huy (2-TCW- 906) declined to respond to the question to avoid self-incrimination. The NUON Chea Defence objected and submitted that in this case the Witness had no right to decline to answer the question.

The Chamber decided that based on the information available to it and the fact that the witness declined to respond to the question, it could not to compel the witness to respond to any question if the witness exercises his right against self-incrimination.
