**Subject:** Nuon Chea's character witnesses

Dear Ken,

The Co-Lawyers for Nuon Chea (the "Defence") have asked me to write in respect of the Trial Chamber's memorandum of yesterday on the final stages of Case 002/02 (**E421**).

The Defence notes that the Chamber has referred to the Defence's request for three character witnesses based on the Defence's indications in its Case 002/02 witness lists. However, the Defence advises that it had erroneously tagged 2-TCW-877 and 2-TCW-962 as being in a position to testify as to Nuon Chea's character, and that only 2-TCW-831 is in a position to offer material testimony as to Nuon Chea's character. The Defence therefore seeks to withdraw its request for 2-TCW-877 and 2-TCW-962's testimony insofar as it relates to Nuon Chea's character.

The Defence seeks the Chamber's guidance as to whether it needs to take any further steps to amend its request in this regard – for instance, by filing a correction to its witness lists – or whether this notice is sufficient.

The Defence thanks the Chamber in advance for its consideration and response, and apologises for any inconvenience caused in this regard.
