Summary of Proceedings

Opening of hearing and report on attendance of the Parties

The President opened the proceedings and the Greffier informed the Trial Chamber that all Parties were present, with the exception of Judge Fenz and Judge Sokhan. NUON Chea present in the holding cell.

NUON Chea Defence request to follow the proceedings from the holding cell

The Trial Chamber granted NUON Chea's request to waive his right to be present in the courtroom and to follow the proceedings from the holding cell.

Hearing of witness Mr. KAING Guek Eav alias DUCH (2-TCW-916)

The NUON Chea Defence posed questions to Mr. KANG Guek Eav alias DUCH (2-TCW-916).

Oral submissions on KHIEU Samphan Defence request (E420)

The Trial Chamber heard oral responses by the Parties to the KHIEU Samphan Defence's request (E420) for the Chamber to clarify the scope of the internal purges trial segment, as well as for the Chamber to reconsider hearing certain witnesses in this segment.

KHIEU Samphan Defence reminded the Parties that the request was a motion for clarification, pursuant to Internal Rule 98(2), on the jurisdiction of the Chamber regarding internal purges. The Defence questioned the reasoning of the Chamber to hear witness 2-TCW-1005, considering the witness was scheduled to testify on the purges in Kratie. The Defence submitted that purges are not crimes as such, but a term used by the Co-Investigating Judge in the Closing Order. It was submitted

that the Chamber's jurisdiction on purges should not go beyond what is established in the introductory submissions and Closing Order: events in the North Zone in 1976 and East Zone in 1978. Based on the Chamber's Severance Decision of May 2014, they are also related to certain crime sites such as Tram Kok cooperative and S-21. The Defence also expressed its concern on the Chamber's decision to hear witnesses on purges identified in Case 003 and 004 investigations. In doing so, the Chamber was extending its jurisdiction in a de facto manner beyond the Closing Order, which forms the Chamber's jurisdiction.

The KHIEU Samphan Defence also questioned to what extent the Chamber would be using evidence on internal purges if it were not within the scope of the trial. Introducing facts that are not part of the Closing Order or Severance Decision, but relate to the role of the Accused and JCE, would contravene Rule 98(2).

The NUON Chea Defence agreed with most of the KHIEU Samphan Defence's submissions, but did not oppose the appearance of witnesses for internal purges sent to S-21, as evidence related to this is very material to their case. The Defence also agreed that "purges" are not crimes as such but a means to categorize events.

The Co-Prosecutor submitted that purges, though not a crime in itself, was part of the policy which led to crimes at sites such as S-21, and is thus relevant to this trial. It is also relevant to KHIEU Samphan's criminal responsibility, as well as the CPK's policy of targeting enemies.

The Lead Co-Lawyer identified their understanding of the Chamber's jurisdiction regarding internal purges. It was argued that the Chamber is limited to the crimes perpetrated in Phnom Kraol, Au Kanseng and S-21 security centres, and the policy of purging existed in the North and East Zones only. It was also identified that the evidence would be relevant to role of the Accused and joint criminal enterprise.

After the oral submissions, the Trial Chamber notified the Parties that the scheduled Civil Party, 2-TCCP-236, would be heard the following day as the Chamber required time to deliberate on the request.
