#### **Summary of Proceedings**

#### Opening of hearing and report on attendance of the Parties

The President opened the proceedings and the Greffier informed the Trial Chamber that all Parties were present, with the Accused NUON Chea present in the holding cell.

#### NUON Chea Defence request to follow the proceedings from the holding cell

The Trial Chamber granted NUON Chea's request to waive his right to be present in the courtroom and to follow the proceedings from the holding cell.

#### Hearing of Witness CHIEL Chhoeun (2-TCW-960)

Questions were put to the Witness CHIEL Chhoeun (2-TCW-960) by the Co- Prosecutor

and concluded by NUON Chea's Defence.

#### Order to proceed in closed session in relation to documents pertaining to 2-TCW-1066

The Trial Chamber ordered tproceedings in closed session allowing that during the examination of 2-TCW-960 Counsel for NUON Chea refers to extracts of documents E3/10685 and E3/10683 pertaining to 2-TCW-1066, which is a protected witness..

# Oral ruling on NUON Chea Request to admit 8 documents and investigative action in relation to 2 documents E445/1

The Chamber refers to the request filed confidentially by the NUON Chea Defence on 11 October 2016 pursuant to Internal Rules 87(4) and 93 (E445/1), seeking the admission of 8 documents and requesting investigative action with respect to 2 documents. Oral submissions in response were heard on 13 October 2016.

Pursuant to Internal Rule 87(4), the Trial Chamber admits documents 1 to 7 and denies the admission of document 8. Given that the Chamber denies the admission of document 8, the request in response made by the Co-Prosecutor to admit three documents is moot. With respect to Document 1, the NUON Chea Defence is instructed to identify those portions of the 215-page document which are most relevant to the anticipated testimony of 2-TCE-98 and which they intend to use.

Having regard to the Rule 93 request, the Chamber has asked WESU to contact the expert to provide a full version of the first requested document. The Chamber denies the Rule 93 request with respect to the second requested document.

Full written reasons for this decision will follow in due course.

#### Hearing of the Witness (2-TCW-1037)

Questions were put to the Witness 2-TCW-1037 by the Trial Chamber, followed by NUON Chea Defence and concluded by the Co Prosecutors.

#### Oral Submission on the Written Notes of 2-TCE-98 pertaining to E3/7338

The Chamber requested the parties to respond to the Co-Prosecutor request of handwritten notes of 2-TCE-98's interview with King Norodom Sihanouk and Ieng Sary in 1983 and 1985 respectively for questioning during the experts testimony.
