- THE PRE-TRIAL CHAMBER of the Extraordinary Chambers in the Courts of Cambodia ("ECCC") notes the "IENG Sary's Request to Summon Medical Experts to Give Evidence during the Oral Hearing on Provisional Detention" filed by the Co-Lawyers for the Charged Person on 10 February 2009 ("Request").
- 2. By their Request, the Co-Lawyers ask the Pre-Trial Chamber to summon several medical doctors for examination at the oral hearing on 26 February 2009.
