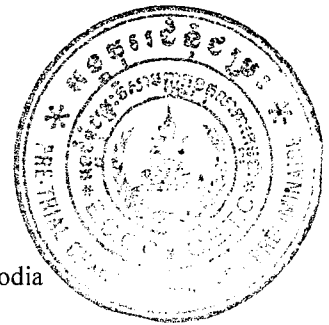

THE PRE-TRIAL CHAMBER of the Extraordinary Chambers in the Courts of Cambodia (“ECCC”) notes the IENG Sary’s Request for an “Expedited Filing Schedule and Public Oral Hearing” (“The Request”) of the “Appeal Against the OCIJ Order on Breach of Confidentiality of the Judicial Investigation” (“The Appeal”).

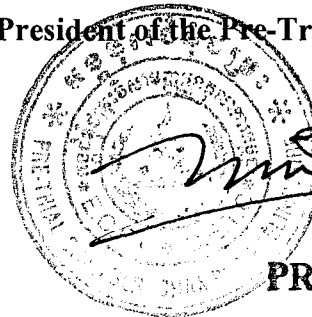
1. By their Request, the Co-Lawyers for the Charged Person ask the Pre-Trial Chamber “to direct the other parties to respond within 7 days of notification of the Appeal” and “to hold the public oral hearing on [the] Appeal on 3 April 2009”.
2. The Pre-Trial Chamber, considering that the Co-Lawyers for the Charged Person raise no arguments why this should be handled in an expedited manner, does not find it necessary to ask the parties for their views and therefore denies the Request.
