- THE PRE-TRIAL CHAMBER of the Extraordinary Chambers in the Courts of Cambodia ("ECCC") notes the Co-Prosecutors' "Joint Response to Defence Appeals against the Co-Investigating Judges' Order Denying Request for Investigative Action Regarding Allegations of Administrative Corruption" dated 29 May 2009 ("The Response").
- 2. The Co-Prosecutors have submitted arguments in respect of the admissibility of the Appeal to which the Pre-Trial Chamber finds that the Charged Person should be given an opportunity to reply.
- 3. The Co-Lawyers for the Charged Person may make submissions in reply limited to the matter of the admissibility of the Appeal. Such submissions shall not exceed 5 pages, excluding the front page of the submission.

# THEREFORE, THE PRE-TRIAL CHAMBER HEREBY DIRECTS:

That any submissions by the Co-Lawyers be filed by 23 June 2009, at 16:00 p.m.
