Dear Judge YOU Bunleng, dear Judge Marcel LEMONDE,

On 25 February 2010, you set a deadline for the submission of supplementary information with regard to the scope of investigation for case file 002, to be filed by 29 April 2010.

On 26 March 2010, Judge LEMONDE publicly mentioned during a meeting of Civil Parties' representatives that the Victims Support Section has been granted one additional month to file the Victims Information Forms to the Office of Co-Investigating Judges. Co-Lawyers for Civil Parties do not have access to the Victims Information Forms and the English reports of the Victims Support Section unless they are on the case file. The Victims Support Section will probably process all forms and reports by the end of the extended deadline, i.e. the end of April, but that does not mean that the forms and reports will be available immediately on the case file.

Given that we rely on this information in order to assess if supplementary information is required,

we here-with respectfully request an extension of the set deadline to
1 (one) month, i.e. until 31 May 2010.
