We acknowledge receipt of your letters of 19 and 20 April 2010, in response to our Memorandum dated 9 April (D337/3) concerning the deadline for filing supplementary information in relation to the initial civil party applications.

After an in-depth analysis of the situation and in view, in particular, of the Memorandum of the Victims **Support Section (VSS)** concerning legal representation of the Civil Parties, we deem it necessary to allow **Civil Party applicants** more time for them, to, if necessary, file supplementary information in relation to **their** Civil Party applications in the light of the press release of 5 November 2009 regarding the seizure of the Co-Investigating Judges in Case 002.

Accordingly, applicants can file supplementary information to the VSS until **30 June 2010 in relation to Civil Party applications that had already been submitted to the VSS up to 29 January 2010.**



Also, considering the need for Civil Parties to be represented by a lawyer who is able to have access to information relating to his **or her** clients and to **have the opportunity to be able to** offer them **considered legal** advice, we will issue an order, by 1 June 2010 at the latest, designating (temporary) lawyers for all those Civil Parties who are not yet represented, under the common legal representation system.
