Decision on Ieng Sary's Expedited Appeal Against the OCIJ's Decision Refusing to Accept the Filing Of Ieng Sary's Response to the Co-Prosecutors' Rule 66 Final Submission and Additional Observations, and Request for Stay of the Proceedings

THE PRE-TRIAL CHAMBER of the Extraordinary Chambers in the Courts of Cambodia ("ECCC") is seized of "IENG Sary's Expedited Appeal Against the OCIJ's Decision Refusing to Accept the Filing of IENG Sary's Response to the Co-Prosecutors' Rule 66 Final Submission and Additional Observations, and Request for Stay of the Proceedings" ("the Appeal")¹ filed on 6 September 2010 by the Co-Lawyers of IENG Sary against the OCIJ's Decision to instruct its Greffier to refuse to accept the filing ("the Impugned Notice")² of IENG Sary's Response to the Co-Prosecutors' Rule 66 Final Submission and Additional Observations ("the Response").³

The Pre-Trial Chamber has determined the final disposition of the Appeal, which it hereby pronounces. A reasoned decision in respect of the Appeal shall follow in due course.

THEREFORE, THE PRE-TRIAL CHAMBER UNANIMOUSLY HEREBY DECIDES:

- 1. The Appeal is admissible;
- 2. The request for a hearing and stay of proceedings is dismissed as unwarranted;
- 3. The Co-Investigating Judges are ordered to immediately cause the placement of the Response in the Case File.

In accordance with Internal Rule 77(13), this decision is not subject to appeal.
