INTRODUCTION

- 1- Pursuant to the provisions of the Internal Rules, the Civil Party Co-Lawyers for Group 3 submit this Notice of Appeal against the Order on the admissibility of civil party applicants from current residents of KEP province, dated 25 August 2010, and notified to the parties on 26 August 2010.

- 5- The appeal briefs of the appealing parties will be filed with the Pre-Trial Chamber within the prescribed time limits.
