NOTICE OF APPEAL

- 1- The Civil Party Co-Lawyers hereby inform the Co-Investigating Judges that they will appeal the Order on the Admissibility of Civil Party Applicants from the Current Residents of Preah Sihanouk Province (“Order”), D401, and in particular from Victim Civil Party Applicants D22/762; D22/491; D22/493; D22/1649; D22/1608; D222/747; D22/863; D22/860; D22/2811; D22/2917; D22/3012; D33/3794; D22/3800; D22/3801; D22/3802; and D22/3813.
- 2- The Civil Party Co-Lawyers received notification of the Co-Investigating Judges’ Order on 2 September 2010, in French and in Khmer. Therefore, this appeal has been filed within the time limit prescribed in Internal Rule 75, i.e. within 10 days of notice of the decision.
- 3- The Civil Party Co-Lawyers will file their appeal brief on 13 September 2010, in compliance with both Internal Rule 77 *bis* (2) concerning the expedited appeal procedure, which provides that the appeal shall be filed within 10 days of notification of the decision on admissibility, and the Co-Investigating Judges’ Order.
