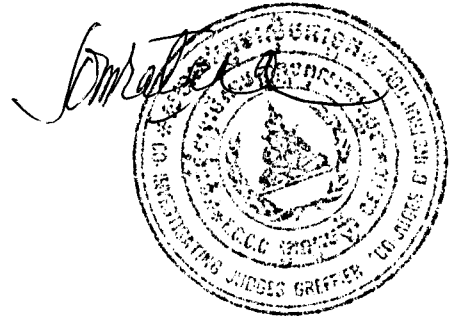

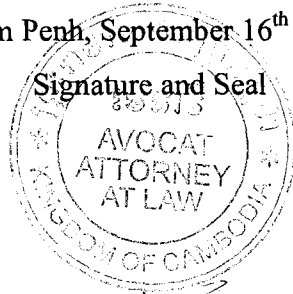


NOTICE OF APPEAL
