### Notice of Appeal from Persons Residing Outside the Kingdom of Cambodia [sic]

- 1- Pursuant to the provisions of the Internal Rules, the Civil Party Co-Lawyers for Group 3 file this appeal against the Order on the Admissibility of Civil Party Applicants from Current Residents of Kratie Province, which was rendered on 8 September 2010 and notified on 9 September 2010.
- 2- The Order declared some Civil Parties admissible while declaring others inadmissible.
- 3- This appeal deals exclusively with those Civil Parties who were declared inadmissible, and concerns the following persons the following persons: 07-VU-00208 D22/2612 (SAN La Nin); 08-VU-00101 D22/0113 (NHAK Sok); 09-VU-01474 D22/2723 (POT Sang); 09-VU-01475 D22/2724 (SRUN Soaphea); 09-VU-01476 D22/2725 (SOK Dim); 09-VU-01581 D22/1893 (LI Muon); 09-VU-01582 D22/20769 (MOM Sarom); 09-VU-1585 D22/0589 (PORN Heng); 09-VU-01586 D22/20588 (CHHUN Reak); 09-VU-01774 D22/2773 (SIEM Pean) and 09-VU-01781 D22/2778 (LONG Pan).
- 4- The Civil Parties' submissions before the Pre-Trial Chamber will be transmitted within the prescribed time limit.

#### **CONCLUSIONS**

- 5- The Civil Party Co-Lawyers request the Co-Investigating Judges:
  - To find their appeal admissible
  - To hold a public hearing and to allow the filing of additional material,
  - To annul the Order,
  - To find the civil party applications of Victims Victims 07-VU-00208 D22/2612 (SAN La Nin); 08-VU-00101 D22/0113 (NHAK Sok); 09-VU-01474 D22/2723 (POT Sang); 09-VU-01475 D22/2724 (SRUN Soaphea); 09-VU-01476 D22/2725 (SOK Dim); 09-VU-01581 D22/1893 (LI Muon); 09-VU-01582 D22/20769 (MOM Sarom); 09-VU-1585 D22/0589 (PORN Heng); 09-VU-01586 D22/20588 (CHHUN Reak); 09-VU-01774 D22/2773 (SIEM Pean); and 09-VU-01781 D22/2778 (LONG Pan) admissible and with merit.
