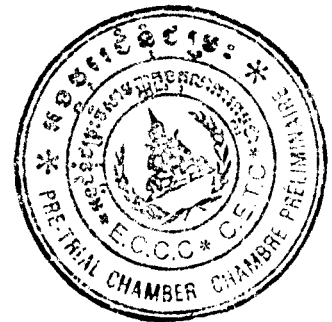

**THE PRE-TRIAL CHAMBER** of the Extraordinary Chambers in the Courts of Cambodia (“ECCC”) notes “Ieng Sary’s Appeal against the Closing Order’s Extension of his Provisional Detention”, filed on 22 October 2010 (“Appeal”).

**ORDER**

1. On 29 November 2010 the Pre-Trial Chamber issued a “Scheduling Order”<sup>1</sup> pursuant to Rule 77(3)(a) of the Internal Rules (Rev. 6), which scheduled the above mentioned appeal for hearing on **15 December 2010** commencing at **9:00 am**.
2. On 3 December 2010 the Co-Lawyers for the Accused filed “Ieng Sary’s Request for Leave to Reply in Lieu of an Oral Hearing & Reply to the Co-Prosecutors’ Response to Ieng Sary’s Appeal against the Closing Order’s Extension of his Provisional Detention” (“Request and Reply”).<sup>2</sup> The Pre-Trial Chamber considers that judicial economy supports the granting of the Request. Therefore, the Appeal will be determined on the basis of written submissions only.

**THE PRE-TRIAL CHAMBER HEREBY:**

- (1) CONFIRMS ITS ACCEPTANCE OF THE FILING** of the Request and Reply;
- (2) CANCELS** the scheduled hearing of the above mentioned Appeal on **15 December 2010** commencing at **9:00 am**.
