Cancellation Order 2/3

THE PRE-TRIAL CHAMBER of the Extraordinary Chambers in the Courts of Cambodia ("ECCC") notes "Ieng Sary's Appeal against the Closing Order's Extension of his Provisional Detention", filed on 22 October 2010 ("Appeal").

ORDER

- 1. On 29 November 2010 the Pre-Trial Chamber issued a "Scheduling Order" pursuant to Rule 77(3)(a) of the Internal Rules (Rev. 6), which scheduled the above mentioned appeal for hearing on 15 December 2010 commencing at 9:00 am.
- 2. On 3 December 2010 the Co-Lawyers for the Accused filed "Ieng Sary's Request for Leave to Reply in Lieu of an Oral Hearing & Reply to the Co-Prosecutors' Response to Ieng Sary's Appeal against the Closing Order's Extension of his Provisional Detention" ("Request and Reply"). The Pre-Trial Chamber considers that judicial economy supports the granting of the Request. Therefore, the Appeal will be determined on the basis of written submissions only.

THE PRE-TRIAL CHAMBER HEREBY:

- (1) CONFIRMS ITS ACCEPTANCE OF THE FILING of the Request and Reply;
- (2) CANCELS the scheduled hearing of the above mentioned Appeal on 15 December 2010 commencing at 9:00 am.
