In accordance with Internal Rule 75 (Notice of Appeal and Submissions on Appeal before the Pre-Trial Chamber), Co-Lawyers for Civil Parties hereby file a Notice of Appeal concerning the decision of the Co-Investigating Judges in the "Order on the Admissibility of the Civil Party Application of Robert HAMILL" (Appellant) (Document number D11/2/3), dated 29 April 2011, and received by the Appellant, Mr HAMILL, via post, at his address in New Zealand, on 12 May 2011.

The Greffier of the OCIJ has informed that a rejection in Case 004 is also made in Document Number D5/2/3. However, no access to the case files in Cases 003 and 004 have been granted to the Appellant's lawyers, and as at 12 May 2011, no Admissibility Order D5/2/3 has been notified or received by the Appellant or his lawyers.¹

This Notice of Appeal serves as a Notice of an intention to file an appeal against both Admissibility Orders D11/2/3 and D5/2/3 (if/when the latter is received).²
