Reference is made to your below mail. The suggestion of regular meetings between Judge Cartwright, the international Co-Prosecutor and the UNAKRT Co-ordinator, keeping their Cambodian counterparts closely informed, was made by the Legal Counsel during her visit to the ECCC in April 2010. The aim was to add focus to communication between the UN component of the ECCC and UN Headquarters. Such meetings would replicate, in an informal way, the coordination committees that are standard in the other UN and UN-assisted tribunals. These meetings concern administrative and organisational matters and do not deal in any way with the substance of the cases before the ECCC.

I understand you have communicated similar request for clarification to the Judge in question and I advise these administrative requests be addressed to my office only.
