**SUBJECT: Further information regarding scheduling of proposed experts**

To assist in planning by the Chamber, parties and the Witness and Expert Support Unit (WESU), the Chamber provides further information regarding the scheduling of the following proposed experts included in the Chamber's partial list of witnesses, experts and Civil Parties for the first trial in Case 002 (E131/1.1):

- David Chandler: will be heard after the summer recess, on a date to be announced from 21 to 25 May 2012 (approximate allocated time for questioning by the Chamber and all parties: 5 days).
- Philip Short: will be heard in the months following the summer recess, on a date to be announced (approximately 6 days).
- Henri Locard: the Chamber advises the parties that this proposed expert will not be heard prior to October 2012. Further information regarding the scheduling of this individual will follow in due course.
- Elizabeth Becker: the Chamber has scheduled the testimony of this individual from 17 October 2012 (approximately 5 days). Confirmation of this will follow in due course.
- Ben Kiernan: revised dates for the hearing of this proposed expert will follow in due course. The Chamber does not currently expect to hear this individual imminently.
- Ea Meng-Try and Anne Guillou: the testimony of these individuals before the Chamber is not currently contemplated. Further information will follow in due course.
