Further to its previous memoranda listing witnesses to be heard and order of call (e.g. E172, E172/10, E194 and E172/24), the Chamber provides the below additional information regarding the order of call of the next batch of witnesses and experts to be heard in the current trial session.

Upon resuming the hearing on 19 June 2012, the Chamber will hear the following witnesses:

- TCW-797 *(on all areas of the Case 002 Closing Order within his knowledge)*
- TCW-321 *(on all areas of the Case 002 Closing Order within his knowledge)*

Following the summer recess, the Chamber will conclude the hearing of the above witnesses not concluded before the recess, and will hear the following witnesses and expert in the below approximate order:

- David Chandler *(on all areas of the Case 002 Closing Order within his expertise)*
(will be heard from 16 to 23 July 2012).
- TCW-564 *(Ministries – B-1 MFA, Movement of Population Phase 1. Historical background)*
- TCW-694 *(on all areas of the Case 002 Closing Order within his knowledge)*
- TCW-490 *(Ministries – B-1 Boeng Trabek)*
- TCW-609 *(Ministries (Propaganda) and Political education by the Accused and Movement of Population Phase 1)*
- TCW-338 *(Ministries (Propaganda) and Political education by the Accused)*
- TCW-91 *(Ministries (Propaganda) and Political education by the Accused)*
- TCCP-186-28 *(Ministries (Propaganda) and Political education by the Accused)*
- TCCP-142 *(Administrative Structures (National))*

Further information will follow in due course. The Chamber reminds the parties that the above order may alter, and that witnesses may be heard in shifts or in half-day sessions where effective trial management so requires.

The Chamber is further consistently provided with updates regarding the health and availability of witnesses by the Witness and Expert Support Unit. The Chamber nonetheless advises the parties that it shall take account of the factors raised in the Co-Prosecutors' Motion for the Prioritisation of Testimonies of Elderly Witnesses (E188 and confidential annex E188.1) and related Civil Party filing (E188/1) to the extent possible within the confines of effective trial management. This constitutes the Chamber's official response to both Motions.
