THE TRIAL CHAMBER of the Extraordinary Chambers in the Courts of Cambodia (“ECCC”);

BEING SEISED of Case File No. 002/19-09-2007/ECCC/TC pursuant to the Decisions on Appeal Against the Closing Order by IENG Sary, IENG Thirith, NUON Chea and KHIEU Samphan, rendered by the Pre-Trial Chamber on 13 January 2011¹;

NOTING its Decision Concerning New Documents And Other Related Issues of 2 May 2012 (E190) (“Decision”), which ordered the parties to upload to the Shared Materials Drive or otherwise make accessible by 11 May 2012 the 37 new documents identified in paragraph 28 of the Decision;

NOTING that the Decision was filed in French on 11 May 2012, and that the parties were unable to upload documents to the Shared Materials Drive between 12 and 16 May 2012 because of ECCC staff holidays;

NOTING that the IENG Sary Defence uploaded one new document (document #8 in E109/6.2) to the Shared Materials Drive on 10 May 2012;

NOTING the Co-Prosecutors’ Response To Trial Chamber Decision Concerning New Documents And Other Related Issues of 11 May 2012 (E190/1), which specified the location of two new documents (documents #233 in E109/4.1 and #17 in E109/4.5);

NOTING that the KHIEU Samphan Defence uploaded 176 new documents (documents #1, #7, #11, #14, #15, #16, #17, #18, #19, #20, #21, #22, #23, #25, #26, #27 and #28 in E109/1.1) to the Shared Materials Drive on 17 May 2012;

NOTING that document #233 in E109/4.1 is already on the Case File as document number E109/2.3R, in consequence of the Decision;

CONSIDERING that the KHIEU Samphan Defence uploaded its documents to the Shared Materials Drive as soon as reasonably practicable after the filing of the French version of the Decision;

CONSIDERING that the 198 new documents provided by the IENG Sary Defence, the Co-Prosecutors and the KHIEU Samphan Defence are *prima facie* conducive to ascertaining the truth in Case 002;

PLACES on the Case File the 198 new documents listed in the Annex to this decision;

REMINDS the parties that it may consider any attempt to rely on any of the remaining 189 new documents identified in paragraph 28 of the Decision to be an application to admit new evidence under Internal Rule 87(4).
