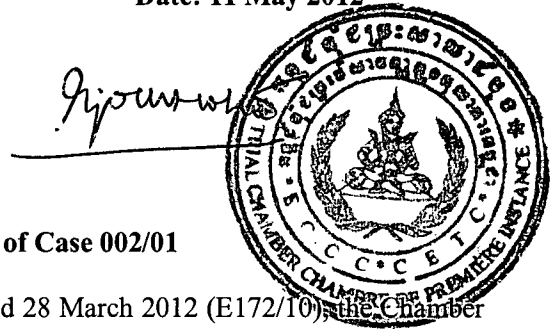

**SUBJECT:** Order of witnesses for current segment of Case 002/01



Further to its memoranda of 17 February 2012 (E172) and 28 March 2012 (E172/10) the Chamber provides updated information on the order of call of witnesses for the benefit of the public. The Chamber has reviewed the Co-Prosecutors' Motion for the Prioritisation of Testimonies of Elderly Witnesses (E188 and confidential annex E188.1) requesting it to prioritise the hearing of certain witnesses based on their advanced age, and to hear them on the totality of the Case 002 Closing Order. The Chamber has also taken into account information provided to it by the Witness and Expert Support Unit on the health and availability of witnesses.

On resuming after the current recess on 17 May 2012, the Chamber will conclude the hearing of Witness PEAN Khean (TCW-504). It will then hear the following witnesses in the approximate order indicated below:

- TCW-487 (Ministries: Ministry of Foreign Affairs, B1)
- TCW-604 (Totality of Case 002)
- TCW-583 (Totality of Case 002)
- TCW-488 (Administrative Structures: Centre)
- TCW-323 (Ministries: Ministry of Foreign Affairs, B1)

The Chamber further advises the parties that Witnesses TCW-321 and TCW-797 may be heard if unanticipated gaps in the courtroom schedule emerge. They will be heard on the totality of the Case 002 Closing Order.

The hearing of the remaining witnesses listed in E172 will be scheduled at a later date, once their availability is confirmed. The Chamber recalls that any of the witnesses listed in E172 may be heard before the Chamber, and that the above order may alter where effective trial management so requires. Where the Accused elect to testify, or where the health of witnesses or effective trial management so require, witnesses may also be heard during half-day sessions, where necessary.
