Summary of Other Proceedings:

Questioning of Witness Chan Khân (KW-32) by the Trial Chamber

The Trial Chamber continued questioning the witness on issues relating to M-13.

The Chamber confronted the Accused with the statements of the witness.

Questioning of Witness Chan Khân (KW-32) by the Co-Prosecutors

The Co-Prosecutors questioned the witness on issues relating to M-13 and read extracts of the Written Record of Interview of CHAN Khân (Document D78/4). They confronted the Accused with the witness' statements.

Questioning of Witness Chan Khân (KW-32) by the Civil Parties

Civil Party Group 1 questioned the witness on issues relating to M-13 and questioned the Accused on issues relating to M-13.

Civil Party Group 2 questioned the witness on issues relating to M-13.

Civil Party Group 2 requested to use Document D59 - Annex 1 (Interview of Chan Khân

by DC-Cam). The Co-Prosecutors and Civil Party Group 1 supported the request.

The Defence reiterated its arguments that DC-Cam is not a judicial body and that no procedural guarantees appear in DC-Cam documents. It objected to the use of these documents.

Civil Party Group 3 requested a general decision on the possibility of using DC Camadocuments.

The Chamber authorised the parties to refer to Document D59 - Annex 1.

The Co-Prosecutors requested the authorisation to use Document No. 19.25 (Annex C of the Introductory Submission, "Report number 65, SIPRA section, about Surrender name Chheun Sothy aka Sarin joined outside the fighting in 15-12-1974.").

The Chamber rejected the request and indicated that it would issue a written reasoned decision on this matter at a later stage. It invited comments from the parties by tomorrow morning.

Civil Party Group 3 questioned the witness on issues relating to M-13 and read extracts from Document D78/4. It questioned the Accused on the testimony of the witness.

Questioning of Witness Chan Khân (KW-32) by the Defence

The Defence questioned the witness on issues relating to M-13 and provided an opportunity for the Accused to address the witness.

The Accused indicated his intention to write a document asking for forgiveness from the victims of Omleang.
