Summary of Proceedings:

Introduction of Other Documents pertaining to "Issues Relating to M-13"

The Trial Chamber inquired with the parties whether they intend to introduce other documents pertaining to "Issues Relating to M-13".

The Co-Prosecutors indicated that they would like to use Documents D59.4 and D59.12 filed during the investigation phase as well as Document 19.25 contained in the Introductory Submissions on the basis that they are relevant to the proceedings. The Co-Prosecutors and the parties also discussed on general principles of admissibility of documents and their use during the proceedings. The Defence requested the Chamber to declare inadmissible Documents D59.4 and D59.12 as well as Document 1.8 from the Introductory Submissions.

The Chamber will issue a decision in due course.

Request to Ensure Accuracy of Interpretations Services and Court Records

During the discussion concerning the introduction of other documents pertaining to "Issues Relating to M-13", the Defence raised the issue of possible inaccuracies in the interpretation of the proceedings as well as in the records thereof and formally asked the Court to ensure their accuracy for the proper conduct of the proceeding.

Clarification on Accused Interview with UNHCHR (Document D9)

The Chamber sought clarification from the Accused in order to determine the circumstances of the taking of his interview with a representative of the UNHCHR in 1999, now contained in Document D9.
