## **Summary of Proceedings:**

## Questioning of Witness Bou Thon (KW-29)

The Chamber, the Co-Prosecutors, Civil Party Group 1 and the Defence questioned witness Bou Thon on the functioning of S-24.

The Accused acknowledged the veracity of the testimony.

## Reading of Written Records of Interview of Phach Siek and Kaing Pan

The Greffier read the Written Record of Interview of Phach Siek (D78/5).

The Co-Prosecutors made some observations on the nature of S-24 (was it really a reducation camp?).

The Civil Parties made no comments.

The Defence notes contradictions between Phach Siek's statement and the testimony of Bou Thon.

The Accused acknowledged the truthfulness of the statement.

The Greffier read the Written Record of Interview of Kaing Pan (D78/3).

The Co-Prosecutors noted a few corrections to the statement.

Civil Party Group 2 referred to Document D59 (DC-Cam interview) and noted that group weddings took place in Stoeng Baku under the order of the Accused.

The Defence made no comments.

The Accused acknowledged that Kaing Pan was a member of S-21 dispatched to S-24. He acknowledged that the statement was true.
