#### **Summary of Proceedings:**

#### Recognition of Foreign Civil Party Lawyer (Rule 23(7)(e)(i)):

Philippe Canonne was introduced by his Cambodian Co-Lawyer and recognised by the Trial Chamber for these proceedings.

#### Questioning of the Accused on the issue of M-13:

The Chamber clarified that the facts relating to M-13 are not contained in the Indictment and recalled the jurisdiction *ratione temporis* of the ECCC. However, it expressed the necessity to examine this topic to have a clearer understanding of the context of S-21 and the motives and personality of the Accused.

#### Documents used during the questioning

The Chamber gave notice to the parties that the following documents would be used:

- "Interview with Ham In", DC Cam (Document D59, Annex 4),
- "Interview with Im Vorn", DC Cam (Document D59, Annex 12),
- "Report 64/75/08. Issue 18" (Introductory Submission, document 19.25),
- Article extract from the DC Cam magazine "Searching for the truth" special English edition July 2003, "The Security system of special zone's office M13" (Introductory Submission, document 1.8),
- "Interview with Duch" (4 May 1999, with the representative of the United Nations Office of the High Commissioner for Human Rights), (Document D9)

#### Use of document D9

The Defence objected to the inculpatory use of document "KAING Guek Eav alias DUM UNHCHR Suspect Statement" (IS Annex C No.20.19 dated 4-6 May 1999), referring Footnote 710 of the Final Submission of the Co-Prosecutors and the subject of Document

D9, because the Accused, as a suspect, was not warned of his right to remain silent.

The Co-Prosecutor argued that this document was already in the case file and requested a decision of the Chamber on whether this document could be used, both in an inculpatory and exculpatory manner.

The Chamber invited the parties to make written submissions (limited to 2 pages in English and French, 4 pages in Khmer) by 8 April 2009 to the Chamber, which will issue a decision in due course.

#### Questioning of the Accused

The Accused was questioned by the Chamber on:

- the political and historical context at this stage,
- the detention of the Accused during the years 1969/1970 and the consequences of this situation.
- the personal position of the Accused when M-13 was created,
- the involvement of the Accused in the CPK.

The Defence requested the interpreter to indicate when he does not understand what is said. It further requested that the names of places and people be shown on a screen when they are mentioned. The Chamber accepted the request and asked the Accused to speak more slowly. The Chamber also indicated that it would make the necessary arrangements with the ICT section for names to appear on the screen.

The Chamber read extracts from the "Written Record of Interview of Duch by the Co-Investigating Judges on 3 October 2007" (Document D21, p.11 in the English version). (p.12 in the French version). It was noted that "M-13K" in this document refers to "M-13A".

- 1 The request by the Civil Party Lawyer for Group 2 to allow them to comment on the Accused response to the opening statement by the Co-Prosecutor was rejected.
- 2 a)- The request by the Civil Party Lawyers to make submissions with regards to the

Defence request to release the accused for the duration of the trial as well as the document filed by the Civil Party Lawyers for Group 3 on 1 April 2009 (Document Number E39) containing submissions in response to the Defence request are rejected.

- 2 b) The Civil Parties are invited to comment on the subsidiary requests made by the Defence that 1) the period of detention before the Military Court by the Accused be taken into account for any sentencing purpose and, that 2) the Accused be entitled to a reduction of any sentence in lieu of compensation for the breach of his rights. Any comment shall be made in writing within 5 days from today.
- 3. The Chamber ordered the parties to make written submissions (limited to 2 pages in English and French, 4 pages in Khmer) by 8 April 2009 on the use of the document entitled "KAING Guek Eav alias DUCH UNHCHR Suspect Statement" (IS Annex C No.20.19 dated 4-6 May 1999), referred to in Footnote 710 of the Final Submission of the Co-Prosecutors and the subject of Document D9.
- 3- Order to take the Accused to the Detention Facility and bring him back to court on 7 April 2009.
