**ORDER ON CO-PROSECUTORS' REQUEST FOR EXTENSION OF TIME TO FILE A JOINT RESPONSE**

**THE TRIAL CHAMBER** of the Extraordinary Chambers in the Courts of Cambodia (“ECCC”);

**BEING SEISED** of Case File No. 002/19-09-2007-ECCC/TC pursuant to the Decisions on Appeal Against the Closing Order by Ieng Sary, Ieng Thirith, Nuon Chea and Khieu Samphan,<sup>1</sup> rendered by the Pre-Trial Chamber on 13 January 2011;

**NOTING** the Co-Prosecutors’ Request for an Extension of Time of 06 June 2011 (E51/12) (“Request”), which seeks a three-day extension of time until 09 June 2011 for the filing of its response to the IENG Sary supplements entitled “IENG Sary’s Supplement to his Rule 89 Preliminary Objection (Royal Pardon and Amnesty)” (E51/10) and “IENG Sary’s Supplement to his Rule 89 Preliminary Objection (*Ne Bis In Idem*)” (E51/11), both filed on 27 May 2011 (“IENG Sary Supplements”), in order to allow sufficient time for translation;

**CONSIDERING** that timely preparation for the Initial Hearing requires the filing of the Co-Prosecutors’ response at the earliest opportunity;

**NOTING** Article 7.2 of the ECCC Practice Direction on Filing and the Trial Chamber Memorandum of 08 February 2011 (E38) which permit the Parties to file documents in one ECCC working language only where it can be shown that translation constraints prevent a party from filing in both Khmer and English and/or French within the relevant deadline;

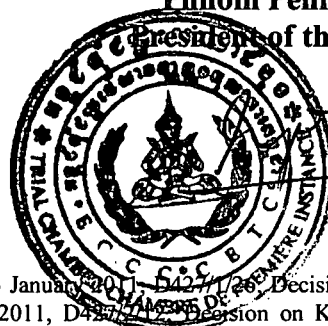
**NOTING** that the Co-Prosecutors received notification of the IENG Sary Supplements three days after its date of filing;

**GRANTS** the Co-Prosecutors a one-day extension of time to file a response to the IENG Sary Supplements, namely until today (07 June 2011) either in both Khmer and English or English or Khmer alone (with translation to follow);

**REJECTS** the Request for a three-day extension of time; and

**REMINDS** the Parties that future requests for extension of time filed on the last day of an applicable time limit are unlikely to be entertained by the Chamber. *gt*
