THE TRIAL CHAMBER of the Extraordinary Chambers in the Courts of Cambodia;

BEING SEISED of Case File No. 002/19-09-2007-ECCC pursuant to the Decisions on Appeal Against the Closing Order by Ieng Sary, Ieng Thirith, Nuon Chea and Khieu Samphan,¹ rendered by the Pre-Trial Chamber on 13 January 2011;

NOTING the IENG Sary Defence team's provision of advance courtesy copies of eight individual preliminary objections, comprising a total of 111 pages in English, and the Chamber's subsequent rejection of these purported filings in view of the page limits set forth in the Practice Direction on the Filing of Documents before the ECCC;

FURTHER NOTING its directions to the parties concerning the required length of filings in relation to preliminary objections at this stage of the proceedings before the Trial Chamber of 18 February 2011 and 22 February 2011, respectively, granting the IENG Sary Defence an extension of the above time and page limits;

CONSEQUENTLY DIRECTS the IENG Sary Defence to file a single preliminary objections submission of no greater than 35 pages (English) or 50 pages (Khmer) no later than Monday 28 February 2011;

PERMITS the IENG Sary Defence to file this submission in English only, if translation constraints prevent timely filing in both languages, provided the Khmer translation is filed at the first opportunity thereafter. ១៧
