#### NOTICE OF JOINDER

- 1. On 29 June 2011, counsel for the Accused Ieng Thirith (the 'Ieng Thirith Defence') filed an objection to the Chamber's announcement that it would place the expert report prepared by Professor A. John Campbell (the 'Report') on the 'Confidential' section of the case file. On 6 July 2011 the Nuon Chea Defence team (the 'Defence') filed a Notice of Joinder to that objection. On 6 July 2011 the Trial Chamber communicated a Memorandum on this issue. On 15 July 2011 the Civil Party Lead Co-Lawyers filed their 'Urgent Request for the Trial Chamber to Amend Memorandum E62/3/10', which was notified (in English) on 21 July 2011 (the 'Civil Parties Urgent Request'). On 22 July 2011 the Ieng Thirith Defence team filed its 'Response to the Civil Parties Co-Lead Lawyers' 'Urgent Request for the Trial Chamber to Amend Memorandum E62/3/10 (formerly E106)' (the 'Ieng Thirith Response').
- 2. For a number of reasons and based on a number of arguments,<sup>6</sup> the Ieng Thirith Defence requested the Chamber to: '(i) [...] find the Civil Parties Co-Lead Lawyers' Request inadmissible; (ii) or, alternatively, to reject the Civil Parties Co-Lead Lawyers' Request in its entirety.' Counsel for the Accused Nuon Chea hereby adopts all observations and arguments in the Ieng Thirith Response to the Civil Parties Urgent Request, *mutatis mutandis*, and joins the Ieng Thirith Defence in seeking the specific relief requested therein.
