REQUEST

- 1. Pursuant to ECCC Internal Rule 39 (4) the Co-Prosecutors request a two day extension of time to file their response to IENG Sary's "Motion to Summon King Father Norodom Sihanouk, Prime Minister Hun Sen, Prince Norodom Ranarridh and Samdech Chea Sim" (the "Motion") which was notified on 10 May 2011. By virtue of Article 8.3 of the Practice Direction on the Filing of Documents Before the ECCC ² the deadline for any responses to this filing is 20 May 2011. During this 10 day period there have been three ECCC public holidays effectively on 13, 16 and 17 May 2011³ when there has been numerous filings in this and other cases at the ECCC from the Co-Prosecutors Office. These filings required drafting and translating in a five official working day period where all the prosecution staff were present. Consequently, the granting of a further two days to respond to this Motion will allow the Co-Prosecutors to more effectively assist the Trial Chamber on the resolution of the issue raised.
