THE TRIAL CHAMBER of the Extraordinary Chambers in the Courts of Cambodia ("ECCC");

**BEING SEISED** of Case File No. 001/18-07-2007-ECCC/TC pursuant to the "Decision on Appeal Against the Closing Order Indicting Kaing Guek Eav Alias Duch," rendered orally by the Pre-Trial Chamber on 5 December 2008 and filed in Khmer on 9 December 2008;

**SEIZED** of the "Co-Prosecutors Request for the Application of Joint Criminal Enterprise" filed by the Co-Prosecutors on 8 June 2009;

**RECALLING** the "Ieng Sary Expedited Request to Make Submissions in Response to the Co-Prosecutors' Request for the Application of Joint Criminal Enterprise in the Case of Mr. Kaing Guek Eav 'Duch'" presented for filing by the Defence for Mr. Ieng Sary, a charged person in Case File 002/19-09-2007-ECCC/OCIJ currently before the Office of the Co-Investigating Judges, on 17 June 2009 ("Request");

**MINDFUL** of the "Decision on Ieng Sary's Request to Make Submissions in Response to the Co-Prosecutors' Request for the Application of Joint Criminal Enterprise" filed on 3 July 2009, rejecting the filing of the Request on the basis that Mr. Ieng Sary is not a party to Case File No. 001/18-07-2007-ECCC/TC;

**HAVING RECEIVED** the "Ieng Sary's Supplementary Submissions in Support of Expedited Request to Make Submissions in Response to the Co-Prosecutors" Request for the Application of Joint Criminal Enterprise in the Case of Kaing Guek Eav 'Duch' & Request for Sanctions Under Internal Rule 35 Due to the Co-Prosecutors Misleading the Court in Their Supplementary Observation on Joint Criminal Enterprise Filed on 31 December 2008" submitted for filing by the Defence for Mr. Ieng Sary on 30 June 2009 ("Supplementary Submissions");

**REITERATING** that leng Sary is not a party to Case File No. 001/18-07-2007-ECCC/TC and, therefore, **FINDING** that he has no formal standing to file the Supplementary Submissions;

FOR THE FOREGOING REASONS, the Trial Chamber

**REJECTS** the filing of the Supplementary Submissions;

ORDERS the Court Management Section to notify the present Decision to the leng Sary Defence.
