## INTRODUCTION

1. Pursuant to the Trial Chamber's "*Order to File Material in Preparation for Trial*" (the 'Order')<sup>1</sup> the Co-Prosecutors will submit their objection to the calling of some of the proposed witnesses and experts by other Parties.
2. In total the Parties, including the Co-Prosecutors, have proposed a total of 1095 witnesses, experts and civil parties. In particular, the Co-Prosecutors have proposed 295 witnesses and experts; Nuon Chea has proposed 527 witnesses and experts (*including* 31 witnesses on the Co-Prosecutors list),<sup>2</sup> 13 experts and 5 civil parties;<sup>3</sup> Khieu Samphan has proposed 35 witnesses (*in addition* to 26 witnesses on the Co-Prosecutors list) and 32 experts;<sup>4</sup> Ieng Thirith has proposed 9 witnesses and experts;<sup>5</sup> Ieng Sary has proposed 5 experts<sup>6</sup> and the Civil Parties have proposed 16 witnesses, 15 experts and 140 civil parties.<sup>7</sup>
3. The Co-Prosecutors notify their intention to object to the hearing of certain witnesses and experts proposed by Nuon Chea, Khieu Samphan, Ieng Thirith, Ieng Sary and Civil Parties.
4. The Co-Prosecutor notifies that the lists of witnesses, experts and the Civil Parties filed by the parties, most of them, are in foreign language. These lists eventually make the national and international Co-Prosecutors difficult in their discussion on whether or not to object to certain witnesses, experts and the Civil Parties.
5. In addition, the Office of the Co-Prosecutors had drafted, in English, the annexes of the lists of witnesses, experts and the Civil Parties that are to object to the proposed lists by other parties. Because of the complexity and the great amount of work, the annexes of the lists of witnesses, experts and the Civil Parties, in English, had just been finished by 3:00pm.

parties. Because of the complexity and the great amount of work, the annexes of the lists of witnesses, experts and the Civil Parties, in English, had just been finished by 3:00pm.

6. It is because of the time as stated above which made the National Prosecutor unable to consider properly and fully, on the lists contained in the annexes in English.
7. In order to have sufficient bases for seeking to understand and consider properly and to assist chamber in the assessment of this objection, the National Co-Prosecutor requests the Trial Chamber to grant it an extension of time for filing this response to the objection to the witness, expert and civil-party lists, so enable the National Co-Prosecutor to have possibility to study precisely beforehand on such witness, expert and civil-party lists that were submitted by the parties, before it could file its objection to those lists.

### REQUEST

8. As stated above the Co-Prosecutor, therefore, request the Trial Chamber to grant an extension an extension of time for filing this response until 15 March 2011.
