

1. On 17 January 2011 the Trial Chamber issued its 'Order to File Material in Preparation for Trial' (**Order**),<sup>1</sup> in which the Trial Chamber directed the parties to 'file their joint list of uncontested facts pursuant to Rule 80(3)(e) no later than 25 March 2011'.
2. On 10 March 2011 the Office of the Co-Prosecutors requested the defence to indicate which elements of the factual parts of the Closing Order they would agree to as uncontested facts, and to inform the Co-Prosecutors of such information by 21 March 2011. On 14 March 2011, the international Co-Lawyer for Madame Ieng Thirith informed the Co-Prosecutors that:
 

We are unable to obtain instructions from our client. Given that we would need her consent for every agreed fact, this is not possible at this time. To act to the contrary would not be in accordance with our professional responsibilities.
3. The defence wishes to inform the Trial Chamber of its current position regarding the uncontested facts.
