NOTING the Judgement of the Trial Chamber in Case 001 against the Accused, KAING Guek Eav alias Duch, issued on 26 July 2010 ("Trial Judgement");¹

BEING SEISED of appeals against the Trial Judgement by the Co-Prosecutors, Accused, and Civil Parties Groups 1, 2, and 3 (collectively "Appellants");²

RECALLING that, pursuant to Internal Rule 108(3) (Rev. 6), the Greffiers of the Chamber notified the Appellants on 22 December 2010 that the Chamber will hold an Appeal Hearing from Monday, 28 March 2011 to Thursday, 31 March 2011, and that "A schedule of hearings, including precise dates and times, will be communicated to you in due course";

RECALLING that on 9 February 2011 the Greffiers of the Chamber requested the Appellants to confirm by 16 February 2011 that a legal representative of their respective parties will be available to attend an Appeal Hearing Management Meeting with the Chamber on Wednesday or Thursday, 23 or 24 March 2011 at the ECCC, and that by 16 February 2011 the Greffiers received such confirmation from all Appellants;

RECALLING that on 17 February 2011 the Greffiers of the Chamber notified the Appellants that the Chamber will conduct the Appeal Hearing Management Meeting on Wednesday, 23 March 2011;
