We, the Co-Prosecutors of the Extraordinary Chambers in the Courts of Cambodia (“ECCC”);

NOTING the Supreme Court Chamber’s issuance of the Summary of Appeal Judgment in Case File 001/18-07-2007/ECCC/SC (KAING Guek Eav)¹ (the “Summary”), delivered on 3 February 2012 in which the Supreme Court Chamber entered a sentence of life imprisonment² against KAING Guek Eav, alias Duch;



NOTING the certified copy of the Summary stating that the Appeal Judgment became final on 3 February 2012³;

NOTING Rule 113(1) of the Internal Rules (“Rules”), which states in relevant part that “[t]he enforcement of a sentence shall be made at the initiative of the Co-Prosecutors”, and Rule 113(2) of the Rules, which states in relevant part that “[t]he Co-Prosecutors shall implement the sentence as soon as a decision of the Chambers becomes final”;

CONCERNED that KAING Guek Eav’s transfer to a prison from the Detention Facility at the ECCC could complicate his participation as a witness in further proceedings before the ECCC;

REQUEST the Director-General of the General Department of Prisons of the Ministry of Interior that KAING Guek Eav begin to serve the remainder of his sentence;

FURTHER REQUEST that KAING Guek Eav continue to be held at the Detention Facility at the ECCC until: (A) his participation in proceedings before the ECCC is no longer necessary, or such transfer no longer poses sufficient inconvenience to ongoing ECCC proceedings, as determined by the Co-Prosecutors; and, (B) the Co-Prosecutors and the Director-General of the General Department of Prisons agree on an appropriate prison to hold KAING Guek Eav for the remainder of his sentence.
