Welcome to the 24th edition of The Court Report. This newsletter is published monthly in an effort to keep the public better informed about court activities.

In the Judicial section, updates from the Pre-Trial Chamber, the Trial Chamber, the Supreme Court Chamber, the Office of the Co-Investigating Judges, the Office of the Co-Prosecutors, and the Victims Support Section are included.

In the Public Information & Outreach section, you find a story about four Cambodian villagers who found information on their missing relatives during an ECCC-sponsored Khmer Rouge Tribunal Study Tour.

The NGO page carries an article on Applied Social Research Institute of Cambodia (ASRIC) and their Cambodian Diaspora Victims' Participation Project (CDVPP) that helps Cambodia diaspora get involved in the Khmer Rouge tribunal.

As usual, we have included calendars with upcoming Court and Outreach Information.

ECCC 2010-2011 Budget Approved

The final version of the 2010 to 2011 ECCC budget was endorsed by donor countries in mid-April.

The approved budget totals US\$ 87.1 million, \$42.9 million for 2010 and US\$ 44.2 million for 2011. The international side is allocated a total of US\$ 65.4 million over the two years, of which US\$ 32.2 million is for 2010 and US\$ 33.2 million is for 2011. For the same period,

the national component accounts for US\$ 21.7 million, of which US\$ 10.7 million is for 2010 and US\$ 11 million is for 2011. All figures are exclusive of contingency.

The approved budget has only minor changes from the original budget request presented to the Steering Committee of UNAKRT and the Group of Interested States to the ECCC in 2009.

As the end of 2009, the ECCC so far has

spent US\$ 78.4 million since 2005, of which US\$ 16.2 million was under the Cambodian side and the other US\$ 62.2 million was for the UN component.

UN Legal Counsel and Deputy Prime Minister Appeal for Financial Support for ECCC

The visiting UN Legal Counsel and Cambodia's Deputy Prime Minister on 19 April jointly called for donors to provide funds to support the Khmer Rouge tribunal.

Under-Secretary-General Patricia O'Brien was in Cambodia to cement the cooperation between the government and the United Nations, following the successful conduct of the first trial against Kaing Guek Eav, alias Duch. She held a series of meetings with senior officials of the government and the Extraordinary Chambers in the Courts of

Cambodia, and issued a joint statement with Deputy Prime Minister Sok An after their meeting.

Together they appealed for the international community to provide funds to the ECCC to ensure that the tribunal is successful, addressing concerns over the court's financial situation, including cash flow.

"Now that the budget of the ECCC for 2010 to 2011 has been approved," they urged in their statement, "[we] call upon the international community to come forward with contributions and pledges to both the national and the international components of the court."

In their statement, Ms O'Brien and Mr An commended the successful completion of the first trial, which drew the strong support and interest from the Cambodian people, and stressed their continued support for the ECCC and their intention to work closely together.

"The ECCC has confirmed its ability to

conduct complex international criminal trials to international standards," they said in the statement. "Both the government and the United Nations are committed to ending impunity for the atrocities of the former Khmer Rouge regime, and fully support and respect the ECCC and its independent judicial process."

During her four-day stay, Ms O'Brien also visited the ECCC and addressed both national and international court staff in a town hall meeting in the courtroom.

In her address, she commended each staff member for their dedication and professionalism in carrying out the court's mandate and stressed that such dedication will not be wasted.

"Your work in fighting impunity for the shocking crimes committed during the Khmer Rouge regime has the firm and unwavering support of the Secretary-General and the United Nations," she said.

US Pledges US\$ 5 Million to the ECCC

After a series of discussions with senior officials of the government and the Khmer Rouge tribunal, the visiting US war crimes ambassador on 31 March announced that the US will contribute US\$5 million to the court's 2010 budget.

Announcing the pledge, US Ambassadorat-large for War Crimes Issues Stephen J. Rapp said that although the funds are pending congressional notification, the money will be dispersed to the UN side of the ECCC. He said he expects the US to continue supporting the court for the next several years along the same line. Last year, the US donated US\$1.8 million to the court.

Prior to the announcement, Mr Rapp and officials of the US Embassy visited the Extraordinary Chambers in the Courts of Cambodia and held talks with court officials, including Acting Director of Administration Tony Kranh, Deputy Director of Administration Knut Rosandhaug and other judicial officials.

With these talks, he said afterwards that he became confident about the independence of the court and found no sign of external influence.

During his short stay, Mr Rapp also met with Independent Counselor Uth Chhorn, responsible for investigating complaints by court employees, and Deputy Prime Minister Sok An to discuss various issues related to the tribunal.

Japanese Director SE Asia Division Visits ECCC

A senior Japanese government official visited the court on 25 March to assess the progress in the judicial process and the challenges ahead. Mr Keiichi Ono, Director of the First Southeast Asia Division, Ministry of Foreign Affairs for Japan, accompanied by a Japanese embassy staff member met with senior management.

Acting Director of Administration Tony

Kranh and Deputy Director of Administration Knut Rosandhaug briefed the officials on the recent developments in judicial proceedings and upcoming judicial activities and discussed financial matters.

Japan is the largest donor to the court, having provided nearly half of the entire budget so far, and continues to contribute financially to the ECCC's operations.

Judicial Updates

Pre-Trial Chamber

During the reporting period, the Pre-Trial Chamber decided on and closed three cases and disposed of a number of procedural and other case-management matters.

On 23 March, the parties were notified of the decision on the application of Nuon Chea for the disqualification of the international Co-Investigating Judge. The Pre-Trial Chamber dismissed the application, finding that none of the arguments are capable of establishing the conclusion that the judge in question lacks impartiality.

On 26 March, PTC notified the parties of the decision on the application of leng Sary under for the disqualification of the international Co-Investigating Judge. The Pre-Trial Chamber found the application inadmissible.

On 6 April PTC notified parties of the decision on appeal against the OCIJ order on Nuon Chea's 16th and 17th requests for investigating actions. The Pre-Trial Chamber found the appeal inadmissible.

At the conclusion of the reporting period, the Pre-Trial Chamber remained seised of 28 appeals and three applications. In addition, six notices of appeal have been filed with the Office of the Co-Investigating Judges and these appeals are being expected to be filed shortly.

Of the pending appeals, one is an additional appeal against the order of the Co-Investigating Judges on the use of statements which were or may have been obtained by torture. Four are

Criminal appeals concerning Joint Enterprise. Three are detention appeals. One is an appeal against an order on request for annulment for abuse of procedure, and another appeal against an order on request for transcription. Two are appeals of orders rejecting requests for annulment and a stay of proceedings, respectively. Nine appeals are related to orders on requests for investigative action. One appeal is related to an order on request to place additional evidentiary material in Case 002. The Civil Parties have filed two appeals against orders related admissibility of their applications. Two other appeals are related to orders on requests for summons of witnesses. One recently filed appeal is related to an order on request for appointment of additional demographic expert. Another recently filed appeal is related to an order issuing warning under Internal Rule

Of the three pending applications, two seek the disqualification of the international Co-Investigating Judge, and the third concerns a request for investigations on a staff member of the Office of the Co-Prosecutors pursuant to Internal Rule 35.

All matters pertain to Case 002.

Trial Chamber

The case against Kaing Guek Eav (alias Duch) closed on 27 November 2009. The Trial Chamber is currently engaged in judgment drafting, with the verdict expected during the first half of 2010.



Supreme Court Chamber

There are no decisions currently pending before the Supreme Court Chamber. The Chamber is not currently operational.

Office of the Co-Investigating Judges

Investigations

During the month of March, OCIJ dealt with the 32 investigative requests received from the parties since the notification of the close of the investigation. Seventeen requests were partially or totally accepted and, as a result, 19 investigation mission: involving 27 witness (or Civil Party) interviews were completed. Furthermore, a number of documents provided by foreign governments or witnesses have recently been placed on the case file.

During the month, the Co-investigating Judges issued 12 orders. Three responses to other filings and two CIJs' notes were put on the case file. Several documents were made public and are

available on the ECCC website:

-Order on Civil Parties' Co-lawyers' 7th request for investigative actions concerning the charge of attack against culture

-CIJs' letters on status of Civil Party applications

-CIJs' response to a defence team's request for information concerning complaints made by potential witnesses

In March 2010, a new Analyst joined the Analyst Unit of OCIJ.

Civil Parties

OCIJ received an additional 571 civil party applications to be analyzed in light of their admissibility.

A total number of 2,607 Civil Party applications are being processed.

The CIJ sent a letter to the civil party applicants declared inadmissible, in which they confirm that the Victim Information Form and the information contained will remain on the case file and will be considered as a complaint.

Outreach

The International Co-Investigating Judge participated in a radio talk programme at 102 FM on "Progress of Judicial Investigation of ECCC" on 9 March; Meeting with NGOs on 16 March 2010 at the Sunway Hotel; ADHOC conference on "Civil Party Representative Workshop" on 26 March 2010 at the Sunway Hotel.

Office of the Co-Prosecutors

Legal Work

In March 2010, the OCP continued its participation in the judicial investigation and the appellate proceedings in Case 002 in which charged persons Kaing Guek Eav (alias Duch), Khieu Samphan, leng Sary, leng Thirith and Nuon Chea are being investigated for crimes described in the Introductory Submission.

The OCP filed its response before the Pre-Trial Chamber to a request to clarify filed Krom, filing on Khmer observations on leng Sary and Nuon Chea's appeals on the summoning of additional witnesses filed its and response to appeal against the OCIJ Order on Nuon Chea's requests for investigative action relating to foreign states.

The OCP also continued to prepare for its final submission to be filed in this case under Rule 66.

Trial Proceedings

After filing its Final Trial Brief and concluding its final oral submissions, the OCP awaits the judgment of the Trial Chamber in Case 001 that dealt with the Khmer Rouge's S-21 Security Centre in Phnom Penh.

Analysis

Amongst many other activities, the OCP maintained and updated its case management database (CaseMap) and analyzed open source and in-house documents and continuously makes preparation for a trial in Case 002 through document analysis.

Individual letter notifications were prepared in response to over 2,000 new criminal complaints received in 2010, to be sent for delivery to complainants in April. These complaints were received from individual complainants through the Victims Support Section.

Outreach

Staff of the OCP attended nine outreach events. All of the Assistant and Senior Assistant Co-Prosecutors, on a rotating basis, attended the sessions held at the court by the Public Affairs Section and spoke to visitors from five provinces. The international Co-Prosecutor, Andrew Cayley, on 4 and 5 March met with school teachers in Sihanoukville and Kampot who teach students the history of the Democratic Kampuchea regime.

Victims Support Section

PROCESSING

Over the month of March, the work of the Victims Support Section (VSS) has been devoted chiefly to analysing and submitting the large number of Civil Party applications received for Case 002. The Section has also been concentrating on assisting Civil Party applicants to gain legal representation.

OUTREACH TEAM FIELD WORK

In March, the Outreach unit sent two teams into the field in order to collect further documentation identification evidence from Civil Party applicants whose applications were incomplete. The teams also proposed attorney (POA) powers of unrepresented applicants. The teams delivered notifications on behalf of the Office of the Co-Prosecutor (OCP) to persons who had submitted complaints to the Court.

The first team travelled to Kandal, Takeo and Kampot and obtained 248 POA's, six lots of supplementary information and 19 identification documents.

The second team traveled to Kampong Chhnang, Pursat, Battambang, Banteay MeanChey, Siem Reap and Kampong Thom Province. They retrieved 220 POA's, 30 lots of supplementary information and three OCP notifications.

POSITION FOR INTERNATIONAL CIVIL PARTY LEAD CO-LAWYER

A major component of the reform of victims' participation in February 2010 was the institution of lead co-lawyers to represent the consolidated group of Civil Parties at trial. The UN has begun advertising for the position of international Civil Party Lead Co-lawyer, the deadline for applications set for 1 May. This is a major step towards implementing the structure of Civil Party representation, and qualified candidates stronaly encouraged to apply to this key position. The national counterpart is expected to be advertised shortly.

DEATH OF AN ESTEEMED COLLEAGUE

Blackman passed away in March after succumbing to a long-term illness. Mr Blackman, originally from the United States, joined the ECCC as a Civil Party lawyer in November 2008. His deep loyalty to Cambodia and background in both common and civil law made him a valuable legal representative for victims.

Members of a variety of Court offices, including international Co-Prosecutor Andrew Cayley, attended Mr Blackman's funeral to show their appreciation for his hard work within the Court and to pay respects to an honoured colleague. He will be missed by all in the Court.

STRENGTHENING RELATIONSHIPS

In March, VSS organized or attended a number of meetings with intermediary organisations, Civil party lawyers and individual applicants to discuss issues of mutual interest and to map a common path going forward in the area of victims rights at the ECCC.

STUDY TOURS VISIT THE COURT

The VSS has continued to represent the victims' angle of the Court's work to the well-attended study tours organised by the Public Affairs Section.

Over 6,000 People Visit the ECCC in 1st Quarter

In the first quarter of 2010, 6,350 people visited the ECCC and Tuol Sleng Genocide Museum as part of the court's Khmer Rouge Tribunal Study Tours. The ECCC organized 18 tours during that period.

The participants have included 6,240

villagers from 11 provinces and 110 students and teachers from the Bak Touk High School in Phnom Penh. Among them were 760 Cham Muslims from Kampong Cham, Sihanoukville and Pursat provinces.

The one day programme allows

Cambodians to learn about the ECCC first hand. Those in attendance begin with a guided tour of Tuol Sleng and after are briefed by court officials in the ECCC courtroom. The study tour is aimed at promoting public knowledge of ECCC proceedings among ordinary Cambodians, especially youth born after 1979 and villagers from rural areas who have less access to media coverage of the court.

In February, 1,390 Study Tour participants attended ECCC's Pre-Trial Chamber public hearings on the appeals against the extension of provisional detention in Case 002. During the three-day Pre-Trial Chamber hearings, 1,775 people, including the tour participants, observed the proceedings from the public gallery.

30 Years of Searching for Answers: Missing relatives found at S-21

For many villagers, a visit to S-21 can be a very emotional experience. Many Cambodians still do not know what happened to their relatives who disappeared during the rule of the Khmer Rouge.

The ECCC's Khmer Rouge Tribunal Study Tours provides an opportunity for a few Cambodians to find missing relatives.

On 25 March, more than 300 villagers, including 150 Cham people, from Kampong Siem district, Kampong Cham province, participated in this outreach programme.

In many cases, people leave their village in the middle of the night in order to reach Phnom Penh the following morning. The group from Kampong Siem was no exception.

In order to catch the ECCC bus, ten families traveled by boat at 2:00 am on Smok lake in Kampong Roling village, Sambor Meas commune for an hour to reach the meeting point, the Neak Pan

roundabout.

All six ECCC buses departed Kampong Cham town at 4:30 am. The buses took them first to Tuol Sleng Genocide Museum (S-21) where the villagers received a guided tour through the museum.

Four villagers from this group discovered photos of their missing relatives at S-21.

After more than 30 years of searching, they finally learned the fate of their missing family members.

In her fourth visit to S-21, Ms Nhim Kim Hoeurn, from Koh Roka village, found a photo of her four year-old niece. Ms Hoeurn, a Civil Party in Case 001, has discovered documentation of four relatives at the former prison.

Ms Hen Chha, of Tameang village, saw photos of her uncle and aunt, relatives she had been waiting to hear from for over 30 years.

"At that time [my uncle] acted as my father. I loved him so much...," Ms Chha said. "Seeing these photos makes me feel despair, they had no chance to survive. From now on what I can do is to pray for him."

First-time visitor to S-21, Ms Yie Ney, from Romeas village, discovered photos of her uncle and grandmother.

"Since 1978 I have been waiting for them," she said. "Now when I see their photos at Tuol Sleng, I think they all died, which make me strongly hate Pol Pot."

Ms Chhorn Ron, Bunteay Tmor village, found a photograph of her cousin who served in the military in 1969.

"I have been waiting to see him for more than 30 years," Ms Ron said, recalling how much she misses him.

ASRIC: Encouraging the Participation of Cambodian Diaspora

Halfway around the world, Cambodian diaspora in the US are learning about the Khmer Rouge trials. Applied Social Research Institute of Cambodia (ASRIC) is transcending boarders and involving Cambodian Americans in the proceedings through its Cambodian Diaspora Victims' Participation Project.

ASRIC is a non-profit, grass-roots organisation committed to supporting the global Cambodian community in light of its genocide. Founded by medical sociologist Dr. Leakhena Nou, ASRIC is institutionally affiliated with the Asian Pacific American Institute at New York University.

ASRIC embraces the moral and juridical obligation Cambodian educate **Americans** about Extraordinary the Chambers in the Courts of Cambodia. To that end, ASRIC has implemented the 2009 Cambodian Diaspora Victims' Participation **Project** (CDVPP), functions instrument participation of survivors who are

interested in filling out and filing Victim Information forms.

ASRIC's outreach is rooted in a desire to educate communities about the ECCC. The CDVPP is committed to transforming victims into witnesses and to facilitate individual and communal healing through justice. As of 2010, ASRIC was the leading filer of Cambodian American victim complaints.

To date, the CDVPP is the most extensive outreach effort to Khmer Rouge genocide diaspora survivors. CDVPP workshops are instrumental in collecting survivor testimonies. They have strategically been held in areas with sizeable Cambodian-American populations: Long California; Santa Ana, California; San Jose, California; Portland, Oregon; Massachusetts; Washington, D.C. (including surrounding areas in Maryland Virginia); and Philadelphia, Pennsylvania.

These workshops were run with the support of local Cambodian community

organizations, including but not limited to the Cambodian Association of Greater Philadelphia (CAGP) and the Khmer Post-Philadelphia Bureau, Cambodian Americans Human Rights and Democracy (CAHRAD), Cambodian American of Oregon (CACO), Community The Cambodian Family, Cambodian Senior Association. The Cambodian Veterans Association, Cambodian American Friends in the greater Bay Area, The Metta Health Clinic in Lowell, MA, and The Cambodian Mutual Assistance Association (CMAA) in Lowell, MA.

ASRIC will continue these outreach efforts for Case 002, and is currently planning more workshops in 2010.
