Serbian Tribunal Officials Exchange Lessons Learned with ECCC

A delegation from the Serbian tribunal visited the Extraordinary Chambers in the Courts of Cambodia to exchange lessons learned with their counterparts in Cambodia.

The eight-member delegation consisted of representatives of the Serbian War Crimes Chamber, the Serbian War Crimes Prosecutor's Office, and the Mission to Serbia of the Organization of Security and Cooperation in Europe. On 3 and 4 March, the Serbians held a series of meetings with ECCC's top officials from the three Chambers, Office of Co-Investigating Judges, Office of Co-Prosecutors, and Defence Support and Victims Support Sections, among other senior officials, to exchange lessons

learned.

The delegation specifically hoped to cooperate and learn from the experience of another internationalised court to better improve their own court and practices. The collaboration was mutually beneficial as the ECCC and Serbian delegation gained insight from each other's challenges and successes.

"Virtual Tribunal" plans for the Future

On 17 February the ECCC signed an agreement to establish the ECCC Virtual Tribunal Legacy Project. Collaboration with the Hoover Institution at Stanford University and the War Crimes Studies Center of the University of California, Berkley will make the project possible.

The Virtual Tribunal will allow the ECCC to make trial-related material, including decisions, filings, trial transcripts and videos of court proceedings, digitally available to the public. This state-of-theart method will consolidate the resources and add expert commentary, educational introductions and explanation, interviews and other multimedia resources.

The ECCC Virtual Tribunal will be available to the public through the trials and will continue to operate after the verdicts are rendered. The ultimate goal is to make court materials easily accessible to the Cambodian people, students and researchers around the world. The public will be able to access the ECCC Virtual Tribunal from schools, universities, law faculties and other sites.

Pre-Trial Chamber Judges Reshuffled

Ms. Catherine Marchi-Uhel from France has assumed her new role as an international judge for the Pre-Trial Chamber as King Norodom Sihamoni appointed her on 23 February.

The appointment was made following the nomination by the UN Secretary-General Ban Ki-moon and the approval by the Cambodian Supreme Council of the Magistracy.

Judge Marchi-Uhel, former reserve judge in the Supreme Court Chamber, replaces Judge Katinka Lahuis from the Netherlands. Judge Lahuis now serves as international reserve judge for the PTC. Ms. Florence Mumba from Zambia, former PTC reserve judge, has been appointed as the new reserve judge to the Supreme Court Chamber.

The PTC is now sitting full time to manage an increased workload.

German Minister Meets ECCC Officials, German Advisors

During his short visit to the ECCC, a German government minister reassured officials of the Khmer Rouge tribunal that Germany remains interested in assisting the work of the tribunal.

Mr. Dirk Niebel, Minister for Economic Cooperation and Development, arrived at the court in the evening of 11 March with a 41-member delegation from Germany and received a warm welcome from H. E. Mr. Tony Kranh, Acting Director of Administration, and other senior officials. The delegation, which included representatives of the parliament, business community, civil society and media, watched a short documentary, "A Day at ECCC", in the main courtroom to get a feeling of the

workings of the tribunal.

Germany is one of the major donors to the court's official funds and has also been supporting victim participation in the judicial process and national reconciliation through various channels.

During the short visit, the minister and members of the delegation learned from representatives of the court, as well as the German advisers, how the tribunal is contributing to Cambodia's national reconciliation and the strengthening of the rule of law.

"We are glad to see how the ECCC is working to bring justice for Cambodians." said Minister Niebel. He then reconfirmed Germany's commitment to support the tribunal's efforts.

The visit of the delegation was part of their three-day tour of Cambodia.

Finland Parliamentarians Visit ECCC

On 5 March, a 15-member delegation from Finland paid a courtesy visit to the ECCC and learned the workings of the tribunal from the court's senior management.

The delegation, consisting of 11 members from the Parliament of Finland and four from the Finnish Embassy based in Bangkok, toured the courthouse and received a briefing. They learned how the public hearings in the court's first case were observed by the packed audience in the 500-seat public gallery.

H.E. Mr. Tony Kranh, Acting Director of Administration, welcomed the delegation

and expressed appreciation for Finland's support of the court through the European Commission. The EC has contributed US\$ 1.3 million so far and pledged an additional US\$ 3 million for the Cambodian side of the ECCC budget.

Mr. Olli Neppenen, head of the delegation and Chairman of the parliament's subcommittee, conveyed that people in Finland are interested in following the Khmer Rouge tribunal and wished for a successful development in the judicial process in the future.

Judicial Updates

Pre-Trial Chamber

During the reporting period, the Pre-Trial Chamber disposed of a number of procedural and other case-management matters.

At the conclusion of the reporting period, the Pre-Trial Chamber remained seised of 24 appeals and five applications. In addition, four notices of appeal have been filed with the Office of the Co-Investigating Judges and these appeals are being expected to be filed shortly.

Of the 24 pending appeals, one is an additional appeal against the order of the Co-Investigating Judges on the use of statements which were or may have been obtained by torture. Four are appeals pertaining to a 9 December 2009 order by the Co-Investigating Judges concerning joint criminal enterprise. Three are detention appeals. One is an appeal against an order of the Co-Investigating Judges on a request for annulment for abuse of procedure, and another appeal against an order on request for transcription. Two are appeals of orders rejecting requests for annulment and a stay of proceedings. Seven are related to orders on requests for investigative action. One appeal is related to an order on request to place

additional evidentiary material in Case 002. The Civil Parties have filed two appeals against orders related to admissibility of their applications. Two appeals are related to orders on requests for summons of witnesses.

Of the five pending applications, four seek the disqualification of the international Co-Investigating Judge, and the fifth concerns a request for investigations on a staff member of the Office of the Co-Prosecutors pursuant to Internal Rule 35.

All matters pertain to Case 002.

Trial Chamber

The case against Kaing Guek Eav (alias Duch) closed on 27 November 2009. The Trial Chamber is currently engaged in judgment drafting, with the verdict expected during the first half of 2010.

Supreme Court Chamber

There are no decisions currently pending before the Supreme Court Chamber. The Chamber is not currently operational.

Office of the Co-Investigating Judges

Investigations

The Co-Investigating Judges announced the closing of the investigations in Case 002 on 14 January. From that date, the parties had a 30-day period to file additional requests for investigative actions. By the expiry of this 30-day period, the Co-Investigating Judges had received more than 30 such requests.

Requests which have been accepted are currently being executed.

The Co-Investigating Judges issued 10 orders and decision notices in response to such legal and investigative requests. OCIJ made two public, an order issuing a warning under Rule 38 to a Defence team and an order refusing a request for further charges.

Civil Parties

The Co-Investigating Judges set a deadline for supplementary information for Case 002 Civil Party applicants who filed applications with the Victims Support Section (VSS) up to 29 January. All relevant documents will need to be sent to the VSS by 29 April.

The VSS filed an additional eight Civil Party applications with OCIJ, bringing the number of applications filed to 2,036.

Four additional junior lawyers, fluent in Khmer, have recently joined OCIJ in order to process these applications in the coming months. (continued on the following page)

Outreach

On 23 February, the international Co-Investigating Judge joined PAS and gave a briefing on the work of the court to 15 students from the International School of Phnom Penh (ISPP).

In February, an Administrative Officer also joined OCIJ to coordinate administrative and logistical matters of OCIJ.

Office of the Co-Prosecutors

In February 2010, the OCP continued to participate in the judicial investigation and the appellate proceedings in Case 002 in which charged persons Kaing Guek Eav alias Duch, Khieu Samphan, leng Sary, leng Thirith and Nuon Chea are being investigated for crimes described in the Introductory Submission of 18 July 2007.

In this case, the OCP also filed its responses before the Pre-Trial Chamber to leng Sary, leng Thirith and Khieu Samphan's appeals against the application of joint criminal enterprise (JCE) on 19 February.

On 12 February the OCP also placed additional evidentiary material on the case file and filed requests for investigative action on 29 January.

The OCP participated in the oral hearings of the appeals filed by leng Sary, Khieu Samphan and leng Thirith before the Pre-Trial Chamber where the charged persons challenged the decisions of the Co-Investigating Judges to extend their provisional detention.

The OCP also continued to prepare for its final submission to be filed in Case 002 under Rule 66.

Trial Proceedings

After filing its final trial brief and concluding its final oral submissions, the OCP now awaits the judgment of the Trial Chamber in Case 001 that dealt with the Khmer Rouge S-21 Security Centre in Phnom Penh.

Analysis

Amongst many other activities, the OCP maintained and updated its case management database (CaseMap) and analysed open source and in-house documents to assess the requirements of making further investigative requests to the Co-Investigating Judges. The OCP has filed more than 35 such requests.

To date, the OCP has forwarded more than 2,500 criminal complaints for inclusion in Case 002. More criminal complaints are currently under review after the expiry of the 8 February deadline. These complaints were received from individuals through the Victims Support Section.

External Activities and Outreach

The OCP considers outreach as an important part of its mandate. Therefore, its members regularly take part in outreach efforts organized both by the court and external agencies. In February 2010, the OCP participated in the following programmes:

On 12 February, Senior Assistant Prosecutor Anees Ahmed addressed trainee magistrates and prosecutors on international criminal law at the Royal Academy of Judicial Professions.

As in previous years, two OCP interns, Bridie McAsey and Annelise Young, coached the Cambodian national team who will participate in the March 2010 Jessup International Law Moot Court held in Washington DC.

Victims Support Section

Although the deadline for Civil Party applications in Case 002 expired on January 2010, complaints continued to arrive in February.

The Office of the Co-Prosecutors set a 8 February 2010 deadline for complaints to be submitted, to ensure they would available for use at trial. Complaints received after that date may be available for Case 002 at the discretion of the Court, and may be utilised with respect to other cases.

As a result of the combined effect of these deadlines, the Victims Support Section received a relatively low number of new victim information forms in February.

New functions of the Victims Support Section

The 7th Plenary Session of the Court's senior officials made significant changes to the Victims Unit. The Unit was renamed the Victims Support Section (VSS) to better reflect its new roles and responsibilities. The Section has been tasked with developing measures of participation beyond that of legal nature.

This is an important development both for the Section and the Court more generally, making it a mandate unlike that of any other internationalised tribunal. The Section has also been given the task of providing administrative support to the new lead colawyers, who will represent the consolidated group of Civil Parties at trial, and of providing additional support to Civil Party lawyers.

VSS Processing Activities

February continued to be a demanding one for the processing team of the VSS. The Co-Investigating Judges announced that Civil Party applications received in previous months have to be filed by 29 March. They have also set a deadline of 29 April for the provision of any supplementary information by those Civil Party applicants who submitted their application prior to the 29 January deadline to the (then) Victims Unit.

Supplementary information typically concerns missing ID cards, addresses, or parts of the alleged facts or crime descriptions. This opportunity is particularly important for Civil Parties who filed their applications prior to November 2009, who must demonstrate a personal connection to those particular locations and specific issues that are under investigation.

VSS Outreach Activities

This month the VSS went on missions to the provinces of Svay Rieng, Prey Veng, Kampot, Siem Reap and Kratie to deliver notification letters from the Office of the Co-Prosecutors to complainants who provided information to the Court. In total, the missions delivered 96 notification letters. As a result, from a total of 420 notifications, initially submitted by the OCP to the (then) Victims Unit for individual delivery, only 55 still remain to be delivered.

Since most Civil Parties have not chosen a lawyer to represent them, the VSS and NGOs (continued on page 8)

ICTJ Workshop Renews Focus on ECCC Outreach

The ECCC hosted a three-day workshop on outreach in transitional justice in the first week of March. The International Center for Transitional Justice (ICTJ) organised the event and invited international outreach experts to share their knowledge and help the court better connect with the Cambodian people.

Representatives from nearly every section of the court were able to listen to the presentations and join the discussion. Topics focused on how to improve current efforts and redesign an outreach strategy for the ECCC.

"The rule is eyes open, ears open," said Mohamed Suma, Executive Director of the Centre for Accountability and the Rule of Law and former consultant for the ICTJ in Sierra Leone. "You have to connect in such ways to create a legacy."

Each discussion and presentation dove deeper into the challenges and opportunities for ECCC's outreach efforts. Court sections were encouraged to examine not only their role in the judicial process, but the greater impact of the ECCC on justice and society in Cambodia.

"You need to respond to them [the people], to listen to what they have to say, try to understand what impact it has on their community, and from there change outreach efforts," urged Refik Hodzic, journalist and Registry Liaison Officer for the International Criminal Tribunal for Yugoslavia (ICTY).

The workshop was the perfect opportunity for ECCC's outreach staff to learn from colleagues who worked under similar pretenses for the ICTY, International Criminal Court (ICC), and with the Special Courts for Sierra Leone. The experts shed light on lessons learned and tips to refocus efforts in Cambodia.

"It is important to make people understand the court, why it exists and what its aim is," said Wanda Hall, founder and director of Interactive Radio for Justice and former outreach advisor at the ICC. "The mission is to educate children, peace and national reconciliation."

The importance of involving the victims and local population was one point that could not be over emphasized and the ECCC was praised for success it has seen thus far.

"I would like to congratulate the ECCC for being able to facilitate 31,400 visitors to the court," said Hall. "There isn't another court that comes close to those numbers."

As PAS restructures its outreach approach, the workshop served as a venue for the input and feedback from each court section. Through a number of discussions during the workshop, the ECCC staff came to understand a more institutionalised approach to outreach is imperative to maximize the efforts of the court.

The workshop was a reminder that the court gives Cambodia more than just a verdict, it leaves a positive legacy.

Reaching Out to Students: Bak Touk High School

More than 7,000 students at Bak Touk High School in Phnom Penh took a special outdoor lecture on the Khmer Rouge tribunal on 1 March, directly interacting with the court's officials.

The Chief of Public Affairs, Mr. Reach Sambath, and Legal Communication Officer Mr. Lars Olsen, explained the ECCC's function and proceedings to the students. Their address was followed by a question and answer period. At the very end, the students took a quiz about the court and those who could answer correctly won prizes, such as ECCC T-shirts and notebooks.

The event is part of a nationwide outreach programme in which officials visit schools across Cambodia. The goal of the programme is to promote awareness and understanding of the court among Cambodian youth.

supporting the work of the ECCC have worked to facilitate and accelerate the process of presenting Civil Party lawyers to the Civil Parties. VSS staff and a number of Civil Party lawyers joined efforts with ADHOC to participate in forums in Battambang, Svay Rieng, Kratie and Kampot, successfully reaching out to hundreds of unrepresented Civil Parties and Civil Party applicants in Case 002.

Outreach staff have also been busy organising and accompanying Civil Parties of Case 002 to attend the pretrial hearings that took place at the ECCC on 11, 12, and 15 February,

concerning extension of provisional detention of leng Sary, Khieu Samphan, and leng Thirith.

For all three pre-trial hearings, the Section's staff organised round-trip transportation for Civil Parties of Case 002, from the Court's Information Centre (in downtown Phnom Penh) to the ECCC. Outreach staff accompanied 26 Civil Parties for leng Sary's hearing, 16 for the hearing of Khieu Samphan and seven for leng Thirith's hearing.

The VSS helplines continue to be active. The helpline operator receives calls from people from many different provinces, generally inquiring about various aspects of the court's procedures.

ECCC Radio Outreach by Cambodian NGOs

As radio is the most popular means for Cambodians to receive information, many Cambodian NGOs have been operating radio programmes on the Khmer Rouge tribunal to support the work of the court.

One the first specific programmes on the ECCC was KRT Watch which was set up the Cambodian Human Rights Action Committee (CHRAC) started and broadcasting in 2005. The programme focuses on the provision of up-to-date news about the legal proceedings in the ECCC and it begins with a popular song composed by the Director of CDP, Mr. Sok Sam Oeun.

Another popular radio station is the Woman Media Center (WMC) FM 102 which has broadcasted *The Truth Programme* from its own radio station since 2007. The programme provides a forum for public discussion on issues surrounding the Khmer Rouge trials.

Other ECCC-related radio programmes broadcasted by Cambodian NGOs include: the Center for Justice and Reconciliation (CJR)'s *Voice of Justice*

and Reconciliation, which promotes justice and reconciliation by facilitating dialogue between Cambodians; the Transcultural Psychosocial Organization (TPO)'s Past in the Present, which aims at initiating reflections on personal and collective guilt and offering emotional support to restore listeners' mental health; and Youth for Peace (YFP)'s You Also Have a Chance targeting the younger audience and assisting them to understand all sides of the complex Khmer Rouge Recently YFP's programme began inviting

former Khmer Rouge members to tell their stories on air.

Other programmes include ADHOC's broadcasting of its KRT Programme (which will unfortunately end after March) and the Documentation Center of Cambodia (DC-Cam)'s radio broadcast on the history of Democratic Kampuchea.

- **11 March 2010**: A delegation of 41 German officials visited the ECCC. The group was briefed by senior representatives of the court, including ADOA.
- **12 March 2010**: 20 Norwegian students from the University of Agder visited the ECCC and were briefed by a Public Affairs Officer.
- **12 March 2010**: A representative from AusAID met with the Chief of Public Affairs and toured the courthouse.
- **16 March 2010**: PAS, VSS, OCIJ attended the NGO update meeting to coordinate outreach work
- **16 March 2010**: 300 people from Kok Po commune, Takeo visited the court and were briefed by representatives from OCP, PAS and VSS. As part of the programme, they also toured S-21
- **18 March 2010**: 300 people from Kampong Siem district, Kampong Cham visited the court and were briefed by representatives from OCP, PAS and VSS. As part of the programme, they also toured S-21

Scheduled Activities- ECCC and Partner NGOs

- **23 March 2010**: 300 people from Ni Tean commune, Kampong Speu will visit the court and will be briefed by representatives from OCP, PAS and VSS. As part of the programme, they will also tour S-21
- **25 March 2010**: A director of the Japanese Ministry Foreign Affairs will visit the court and meet with ADOA and DDOA.
- **25 March 2010**: 300 people from Koh Sotin district, Kampong Cham will visit the court and will be briefed by representatives from OCP, PAS and VSS. As part of the programme, they will also tour S-21
- **26 March 2010**: 10 students and professors from Transcend Japan will visit the court. They will receive briefings from PAS, OCP, and DSS.
