


1. Disagreements between the Co-Investigating Judges (“CIJs”) in this case were registered on 22 February 2013, 5 April 2013, 21 October 2015, and 16 January 2017.
2. On 20 January 2017, in my Notice of Intention to Add Modes of Liability by way of Judicial Order and of Provisional Discontinuance (“Notice”),<sup>1</sup> I informed the parties of my intention to add additional modes of liability in relation to the crimes charged on 9 December 2015<sup>2</sup> by way of written order amending the charges.
3. In my Notice, I invited the parties to make submissions on the matter.<sup>3</sup>
4. On 1 February 2017, the International Co-Prosecutor filed his Response,<sup>4</sup> stating that he does not object to the use of a judicial order to amend the charges against Yim Tith.<sup>5</sup>
5. Yim Tith did not file any submissions on the matter.

**I, THEREFORE:**

6. **INFORM YIM Tith** of the amended charges as set out in the Annex to this order and that this Annex now sets out the complete charges against him.
