THE SUPREME COURT CHAMBER of the Extraordinary Chambers in the Courts of Cambodia for the Prosecution of Crimes Committed during the Period of Democratic Kampuchea between 17 April 1975 and 6 January 1979 ("Supreme Court Chamber", "Chamber" and "ECCC", respectively);

NOTING that on 16 November 2018, the Trial Chamber pronounced its verdict and sentence in Case 002/02 by rendering an oral summary of its findings and the disposition of the judgment and subsequently notified the written judgment to the Parties on 28 March 2019 in Khmer, French and English ("Trial Judgment");<sup>1</sup>

**BEING SEISED** of appeals against the Trial Judgment lodged by the Co-Prosecutors<sup>2</sup> and KHIEU Samphân,<sup>3</sup> as well as the Parties' respective responses thereto;<sup>4</sup>

**RECALLING** that the President of the Supreme Court Chamber announced at the conclusion of the appeal hearing on 19 August 2021 that the Chamber would notify the date of the pronouncement of the Appeal Judgment in due course;<sup>5</sup>

**PURSUANT TO** Internal Rules 104 *bis*, 98(1), 102(1);

#### **HEREBY:**

**NOTIFIES** the Parties that the Appeal Judgment in Case File No. 002/19-09-2007-ECCC/SC concerning the Accused, KHIEU Samphân, will be pronounced on Thursday, 22 September 2022 at 9:30 a.m. in the main courtroom of the ECCC.
