**SUBJECT:** Decision admitting new OCIJ Prisoner List



1. On 30 March 2016, the Trial Chamber received an interoffice memorandum (“Memorandum”) from the International Co-Investigating Judge (“ICIJ”) notifying the Trial and Supreme Court Chambers of the product of its S-21 analysis project. The ICIJ informed the Chamber that an analyst, under the supervision of the Analyst Unit Team Leader within the OCIJ, had prepared a new S-21 prisoner list (“S-21 Prisoner List”) based upon S-21 contemporaneous documents collected from Tuol Sleng and the Documentation Center of Cambodia. The Chamber was also provided a list of documents relied upon by the OCIJ analyst in preparing the S-21 prisoner list (“List of Documents”). On 31 March 2016, updated lists were provided to the Chamber with a complete set of ERN numbers.

2. The Chamber considers that it is conducive to ascertaining the truth to admit on its own motion the Memorandum, the S-21 Prisoner List and the List of Documents pursuant to Internal Rule 87(4). The S-21 Prisoner List directly pertains to a topic in Case 002/02 on which the Chamber is set to hear evidence. In addition, it was prepared by a judicial entity of the ECCC and therefore satisfies the *prima facie* standards of reliability and authenticity. The Memorandum and List of Documents, also prepared by a judicial entity of the ECCC, are necessary to fully understand the S-21 Prisoner List and therefore conducive to ascertaining the truth. The Chamber considers accordingly that they should also be admitted.

3. The Chamber notes that the admission of these documents responds to the NUON Chea Defence request to obtain pertinent new evidence created by the ICIJ in Cases 003 and 004 (T. 31 March 2016, p. 74 (Draft)). The Chamber further notes that the S-21 Prisoner List and List of Documents contain ERN numbers for each of the documents which are either already on the Case 002 Case File or have been placed on the Shared Materials Drive on a progressive basis since 2014 (E308/4). Therefore, the S-21 Prisoner List appears to consist of an analysis of contemporaneous documents which were previously available to the parties.
